That I the under signed would like to you, I a widow having my minor children's. That taking the advantage of my help less situation some local person namely Shyamfuliya Sahani, Mukhiya Sahani, Bharat Sahani, Bina Sahani, Rabina Shani, Rinki Sahani always tried to create pressure upon me to garb my house and extort money from me.

That the male members of the family use to consume alcohol every day and use to pass bad comment over me taking my helpless situation. That on the last night at about 10 P.M when Mukhiya Sahani, Bharat Sahani again in a drunken situation pass bad comments over me, I oppose the same and informed everything to the female members of their family.

That after this situation in place of deterring Mukhiya Sahani, Bharat Sahani, the female members Bina Sahani, Rabina Shani, Rinki Sahani have started to bit me and Mukhiya Sahani, Bharat Sahani also joint them, when my minor children's and my tenant come forward to save me, they all physically assaulted my tenant Saiful Alam and my minor Children.

That due to their heavy physical assault, I am unconscious and my minor children's save me. \

That today morning when I am coming to your office to lodge a complaint against them, somehow, they got the information and to resist me they again abuse me my filthy languages and threaten if I

go to police station, then at night they will burn my house along with me and my children and no one able to save me.

That under the above circumstance I want to request your authority to kindly take necessary steps against Shyamfuliya Sahani, Mukhiya Sahani, Bharat Sahani, Bina Sahani, Rabina Shani, Rinki Sahani(I can identify all of them by face) , resident of Bisra Munda Mat, Dakshni Palash, Under Champasari Gram Panchyat, P.O. - Champasari, P.S. - Pradhan Nagar, District- Darjeeling, Pin code - 734003, to ascertain the truth and protect my life and life of my minor children.
