Sir,

With due respect and humble submission, I SI Manoj Kr. Roy of Matigara P.S do hereby lodge this written complaint to the effect that today on 06/04/2025 I was deputed to perform K-32 Van duty along with force, since 06:00 hrs vide Matigara P.S. C.C. No. 2580/25, Dated – 06.04.2025 and Matigara P.S. GDE No. 276, Dated – 06.04.2025 in course of said van duty I received source information that 01 (One) Tractor Blue colour bearing Reg. No. WB 74 BU 6686 fitted with trolley is standing at BDO Office More under Matigara PS area loaded with riverbed materials which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed at BDO Office More under Matigara PS and found the above noted vehicle loaded with river stone chips standing there. On seeing the Police team the driver of the vehicle managed to flee away from the spot, leaving the vehicle abandoned. It is crystal clear that the driver/owner of the vehicle Tractor Blue colour bearing Reg. No. WB 74 BU 6686 fitted with trolley procured the loaded riverbed materials from somewhere clandestinely and was proceeding to sale the same to his designated customer for his wrongful gain. I tried hard to trace out the driver / Owner of the vehicle but in vain. Nobody came forward to claim the vehicle.

Finding no other alternatives, I seized the vehicle Tractor Blue colour bearing Reg. No. WB 74 BU 6686 fitted with trolley loaded with riverbed materials under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S. The seizure was made in between 09:35 hrs to 09:45 hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver/ owner of the seized vehicle Tractor Blue colour bearing Reg. No. WB 74 BU 6686 fitted with trolley loaded with riverbed materials and arrange for its investigation.
