Sir,

With due respect, I SI Shib Sankar Das, S/o- Nirmal Das of Matigara PS, SPC would like to inform you that on today i.e. 06.04.2025 at about 10.45 hrs received specific information that river bed materials loaded few tractors with trolley was running illegally at Fulbari Patan river side area and diarized the matter vide Matigara PS GDE No. 290, Dated- 06.04.2025. Accordingly I informed the matter to I/C, Matigara PS and as per his direction at the same time myself along with SI Avijit Banik, C/868 Sujal Roy, C/523 Sanjit Kundu left PS for Fulbari Patan river side. On being reached at there, I saw many tractors were running with river bed materials. Seeing the Police vehicle, they started to fled away. Anyhow, we managed to detained 03 numbers of Tractors displaying Registration No. WB-73-E-5328, WB-73-E-0806 and WB-73-E-8572 with drivers. On being asked, the drivers of the respective tractors could not produce any valid documents. Then, I just started to seizure procedure of the said vehicles, suddenly Subodh Singha, Sunil Singha, Bijay @ Pechu Singha, Bapi Bhattacharya and other 15 to 20 local people came towards us and started using filthy languages. I repeatedly requested them to co-operate us, but in vain. They also physically assaulted to me and took away the detainee drivers by applying force upon us. They also unloaded the Tractor trolleys in front of us and taken away the said vehicles. They also threatened me that this is their area and Police should not come there. They all are deter to us from discharge our Govt. duty. Later myself along with others left the spot for PS and I treated at Matigara BPHC.

Under the above fact and circumstances, I requested to you that a specific case may kindly be started as per proper section of Law against the above noted accused person and arrange for its investigation.
