Sub: First Information Report.

I, Narayan Barai, Son of Gopi Ram Barai, resident of Ward No. 11, Khudiram Pally, Siliguri, District- Darjeeling, West Bengal, being the father of Nabin Barai, would like to lodge this complaint and state as under:

That on 04.04.2025 at about 02:05 hours, my son, namely Nabin Barai, aged about 29 years, was returning back home on his Honda Activa Scooty being No. WB 74 AQ0046, when an unknown person rashly driving a four wheeler car sedan car (the name and identity of the miscreant and the vehicle no. could not be traced) rammed through my son's scooty at Ashok Dutta More, Near Bandhan Bank Ltd., Hakimpura, Siliguri and after causing the accident, the miscreant fled away with the car, without extending any aid to my son.

My son was left stranded until 02:06:09 hours, when a passer by came to check if he was still alive. Further, he was brought to the civil hospital and when he came to know of the accident we admitted my son to the Shanti Nursing Home and Hospital and he has sustained multiple injuries and is in the I.C.U. ever since and is fighting for his life.


It is pertinent to mention that it is a clear case of hit and run and subsequently attempt to murder as it was very much within the knowledge of the miscreant that his willful act of stranding my son after the accident can also lead to his death. We have obtained the C.C.T.V. footage of the entire incident from a shop at the place of occurrence, wherein it is evident that the car driver has acted negligently and has left my son on the street to die.

I request you to kindly treat this case as urgent and take appropriate legal action/s against the miscreant and oblige.

This FIR has been drafted by Adv. Pooja Maiya and explained to me in vernacular.


