Respected Sir,

I would like to bring to your kind attention that an incident of theft occurred at my residence at Madhya Shantinagar on 07-04-2025 at evening time between 03:30 PM and 09:25 PM.

When I returned from office around this evening 09:25 pm. along with my wife, we found out that our main entrance gate lock was broken and on entering the room we found out that all our rooms were vandalised, our cupboards and almirahs were broke open and all our clothes were brought out from almirahs, beds and the thief vandalised the whole rooms. The theft incident took away our valuable items which includes

2. Gold Bangle (Bala) - 1 piece
3. Gold Earrings - 5 sets
4. 2 sets of Sonata wrist watches.
5. Adidas Black shoe - 1 pair.
6. Redmi Mobile phone.

I would request you to take prompt and necessary action in this matter to recover my valuable items as early as possible and kindly do keep close surveillance around the place of my residence as these incidents are very traumatic to my family members to live in this place.
