1. That at presently I am an old aged widow lady and my age is 72 years and after death of my husband I am getting pension and my life is depend on my said pension and residing at my house at Bhujiapani, P.O. & P.S. – Bagdogra, Dist- Darjeeling and the property where I reside stands in my name .
2. That I am residing at my aforesaid house with my younger son namely **DHANANJOY CHOUDHURY (BAPPA)** since long years ago.
3. That my said son namely **DHANANJOY CHOUDHURY (BAPPA)** was married with **Smt. Sneha Choudhury** since last 3 years ago and since after the marriage of my said son started to misbehave with me as instigation by my said daughter-in-law and sometimes my son and his wife force me to transfer my house and land in their name by different means and my said son and his wife assurance me that they will manage and operate my monthly pension by them and handed over monthly pension amount to me monthly and on entrust upon them I handed over all my pension documents to them but since from last 3 years my said son and his wife never handover the monthly pension to me and misappropriated my monthly pension amount i.e. Rs. 18,000/- per months (approx.) from last 3 years.
4. That my said son and his wife did not provide me any food and they behave me like a servant in my house and I spend my life in a very striengent condition and my living place in not fit for living separately and both my son and his wife did not allow me to talk with any one so that I did not disclose the matter to any one and the living place was not fit to live.

5. That being I am old senior citizen I am become helpless to fight against my said son and his wife and my life become very intolerable condition and I tolerate all the mental torture so that my son will understand my problem but all are in vain and now my life is full of struggle.

That my said son and his wife forcefully taken all my pension documents and paper and all my original ID Cards in their custody and I become unable to taken out my pension from my account and I become very week and my said son and his wife also not treated my treatment by doctors and taken all my original documents in their custody. And my said son and his wife taken my all amount from my account without my knowledge.
7. That on **01-04-2025 at about 11.00 a.m.** I call my elder son for my help by managing to contact him and my elder son namely Partha Choudhury came to my house and rescue me then I told him to lodge FIR against my said son and his wife and also take legal action against them.
8. That from last three years I spend my life in very striengent condition and my said daughter-in-law always threaten me that she belong to a family of police and no law restrain to do illegal act upon me. And my life is in danger and not in safe condition and both of them plan to murder me at any moment of time to take my property and also take my several signatures on several papers reason best known to them with intention of forgery.

So, I therefore request you to kindly to investigate the matter and take necessary action against the above younger son and his wife and save my life from their hands and recover my all original documents from their custody.
