There was some loss in company and they blamed me for the loss. I am ready to show them all the proper calculation & document but they are not interested to any discussions. Last evening 08/04/2025 about 8.30 - 9.00 pm they started beaten to me brutally and confined me on the office room. They also forcefully signed me

ready to sign but they forced me to do so and
beaten me until I signed on the paper. They
have tortured upon me, approx 1.5 to 2 hr by waist
belt, stapled pin & cable wire. They also threatened
my wife on calls like "mam amari bonobor to
kore banen to, rakshak kora banen to,
ammar banite ki karon nimn mat amara?
kintu banen to kare amara korar any kish
pur hoi mat. Ammar barir hi amar to?"
They also snatched my Aadhar from my wallet.
