Respected sir,

I, SMT. PRITI SAHA, W/o- Arjun Saha, R/o- Hakim Para, Raja Ram Mohan Roy Road, near- Old Malaria Road, Siliguri, Dist.- Darjeeling, would like to draw your kind attention to the following effect that- in the year of 2024, November aforesaid said persons i.e., Sl. No. 1 to 4 told me that as I am an unemployed person so I can earn money from my home by deposit my gold ornaments for 1 month & on good faith I delivered/handover my all gold ornaments like :-

1. Gold Chain, weighing :- 19 grams
2. Gold Chain, weighing :- 24 grams
3. Gold Finger Ring, weighing :- 05 grams
4. Gold Finger Ring, weighing :- 05 grams
5. Gold Finger Ring, weighing :- 08 grams
6. Gold Bracelet, weighing :- 18 grams
7. Gold Necklace weighing :- 20.3 grams
8. Gold Ear Rings weighing :- 07 grams
9. Gold Bangles weighing :- 37 grams
10. Gold Mantasha, weighing :- 22.28 grams
11. Gold Necklace weighing :- 20 grams
12. Gold Ear Rings weighing :- 06.27 grams
13. Gold Sitahar weighing :- 40.22 grams
14. Gold Chur weighing :- 21.350 grams

15. Gold Ear Rings weighing :- 05 grams
16. Gold Locket weighing :- 05 grams
17. Gold with Pearl Necklace weighing :- 05 grams
18. Gold Chur weighing :- 30 grams
19. Gold one Pair of Ear Ring & Finger Ring weighing :- 7.94 grams & other items total weighing about 350 grams approx..

In the hands of aforesaid accused NO- 1 with the consent of aforesaid accused NO- 2 & 3, accordingly the aforesaid person i.e., accused NO- 1 handover Rs. 90,000/- cash to me for one month. Thereafter I several times requested to the aforesaid persons i.e., accused No- 1 to 4 to return my gold ornaments but they moving me here & there just like a shuttle cock, in different times accused No- 1 told us that the said gold was kept in Jaigaon in his uncle's House i.e., aforesaid **SUSHIL SARKAR** i.e., accused No- 7 aforesaid. But during further enquiry we came to know that aforesaid persons kept my gold ornaments in **DHENU KRISHNA JEWELERS, SITUATED AT SARKAR MANSION, GROUND FLOOR, HILL CART ROAD, SILIGURI** i.e., accused No- 6. It is to be noted that in the month of August, 2024 the aforesaid persons i.e., accused No- 1 to 5 assured us if we will give him Rs.1,00,000/- for 10 days then they will return Rs. 5,000/- as interest. In this way they looted Rs. 20 lacs hard earn money in cash on different occasion till the date. That my strong presumption is that our entire money is in custody of accused NO- 7 & 8 i.e., **SUSHIL SARKAR & SUMITRA SARKAR**. The aforesaid persons are conjointly hatched up a deep rooted conspiracy to cheated our hard earn money actually they hypnotized me & my husband and presently we are suffering from financial hardship.

In view of above you are requested to take proper legal action against the aforesaid persons and after take cognizance of the matter booked them as per the law & recover our hard earn money & our gold ornaments.
