

Subject : F.I.R

Sir.

In producing herewith one arrested accused namely Shyam Roy (49 yrs approx), S/O- Lt. Hari Kishore Roy of Alsia Bazar, Chaitanyapur, PO- New Rangia, PS-Matigara, Dist- Darjeeling along with seized vehicle dumper bearing Display No. WB 73 D 6443 loaded with river bed materials along with related documents. I ASI Pema Dorjee Sherpa of Matigara P.S, SPC do hereby lodge a written complaint against the above noted accused person to the effect that on 11.04.2025 during night van duty received an information from reliable source that one dumper loaded with illegal riverbed materials coming towards Shivmandir underpass under Matigara PS. On receiving the information I informed the matter to the I/C Matigara PS and as per his kind order myself along with C/219 Sanatan Chitrakar, C/523 Sanjit Kundu and C/868 Sujal Roy rushed to the spot to work out the information. At around 01:10 hrs I found the said dumper bearing Display No. WB 73 D 6443 is coming towards Shivmandir underpass and loaded with river bed materials. Subsequently, I asked the driver to produce valid documents / papers of the said river bed materials, but he failed to produce any valid documents in support of said materials. I searched for independent witnesses but due to late night I could not find any witnesses. As such I seized the above noted loaded dumper and one D/L bearing no- WB73 1998 0337838 in the name of Shyam Roy under proper seizure list in presence of police witnesses and arrested the driver namely Shyam Roy (49 yrs approx), S/O- Lt. Hari Kishore Roy of Alsia Bazar, Chaitanyapur, PO- New Rangia, PS-Matigara, Dist- Darjeeling under proper memo of arrest and brought the above noted vehicle at P.S. The whole seizure process was made under videography and in between 01:20 hrs to 01:30 hrs.

Therefore I pray before you a specific case may kindly be started against the owner and driver of the vehicle namely Shyam Roy (49 yrs approx), S/O- Lt. Hari Kishore Roy of Alsia Bazar, Chaitanyapur. PO- New Rangia, PS-Matigara, Dist- Darjeeling and the seized vehicle bearing Display No. WB 73 D 6443 under proper section of law and arrange for its investigation.
