In producing herewith the following accused person namely Sanjay Biswakarma (43 yrs) S/O Late Sany Biswakarma of Janglikotha, Mohar Gaon Gulma Tea Garden, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following seized articles under proper seizure list viz :- 05 (five) bottles of COSMOS FIFTY INDIA MADE LIQUOR DELUXE WHISKY each bottle containing 750 ml i,e, total (75- ml x 5 = 3.750 ltrs) marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1", (ii) 10 (ten) bottles of "KINGFISHER IMPERIAL STRONG BEER" each bottle containiong 650 ml i,e, total (10 x 650 ml = 6.5 ltrs) marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B". I, ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodged this written complaint against accused namely Sanjay Biswakarma (43 yrs) S/O Late Sany Biswakarma of Janglikotha, Mohar Gaon Gulma Tea Garden, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 08.04.25 at 14.05 hrs I received source information that one Sanjay Biswakarma of Janglikotha, Mohar Gaon Gulma Tea Garden, PS- Pradhan Nagar, Dist. Darjeeling is selling illicit liquor illegally at his residence and he stored huge quantity of illicit liquor at his residence without any valid documents. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No. 379 dated 08.04.25 and informed the matter to you. As per your kind order and direction, I along with SI Goutam Mallick, SI Rajiv Subba, ASI Biplab Kr Das LASI Mithu Kabiraj, C/1411 Ashok Roy C/1413 Sujit Sarkar all of Pradhan Nagar PS left for Janglikotha, Mohargaon Guma Tea Garden under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. On arriving at the spot and contacting my source. Then as identified by the source, I along with other officers and force entered into the residence of said Sanjay Biswakarma and conducted a raid and managed to detain him. On interrogation he disclosed his identity as noted above. On further interrogotation he disclosed that he is selling liquor at his residence without any valid documents. On search the above noted illicit liquor was recovered from his residence. On demand he failed to produce any valid documents or licence to possessissing/storing such illicit liquor. As he willfully violated the norms of Bengal Excise Act hence, I seized the above noted illegal liqior from his possession under proper seizure list in presence of witnesses. The entire process of search and seizure was made in between 14.50 hrs to 15.10 hrs under the coverage of videography. Subsequently, I arrested the above noted detained person namely Sanjay Biswakarma (43 yrs) S/O Late Sany Biswakarma of Janglikotha, Mohar Gaon Gulma Tea Garden, PS- Pradhan Nagar, Dist. Darjeeling after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Sanjay Biswakarma (43 yrs) S/O Late Sany Biswakarma of Janglikotha, Mohar Gaon Gulma Tea Garden, PS- Pradhan Nagar, Dist. Darjeeling for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.
