Darjeeling – 734003, write you this F.I.R. against a person namely 1. BABLU KUMAR SHA, S/O Lal Dhar Sha, resident of Siliguri, Sevoke Road, Prakash Nagar, Ward No. 43, S.M.C., Jalpaiguri, W.B. – 734001 (Ph. No. 62870 36258 / 92203 03820).

That I have known Bablu Kumar Sha for the past seven months. That we met each other through mutual friends and thereafter Bablu and I became friends. That during the month January, 2025 he requested me to let him stay with me for few days and provide him and his small daughter aged 5 years namely Jeva Arohi, he works at the Siliguri Regulated Market, he further stated that he would stay with his small daughter with me in my rented house as he is not getting any house to stay and continue his daily job purpose at Siliguri Regulated Market.

That upon having developed a sense of trust towards Bablu, since 16/01/2025 I allowed him and his daughter to reside with me at my rental place for few days. Few weeks passed and I had to visit my house at Bihar for the occasion of Holi so I handed over the keys to my rented room and left for Bihar on 2nd March, 2025. When I left for Bihar I had kept my Bike in the varanda within the premises of my rented room along with the bike key along with all the documents of my bike in a bag-pack which I had kept in the door hanger.

That while I was away at Bihar, I used to call him daily from 02/03/2025 to 03/04/2025 and we used to speak where he kept me updated about everything. On 04th April, 2025 I then informed him via whatsapp text that I reached Siliguri, and then I reached my rental premises I noticed that my bike was not there, I unlocked the main door and searched for the key of my bike and the documents in the bag-pack, I did not find anything in my bag-pack. Then I tried to contact him but his all phone numbers were not-reachable. Ever since then I have been worried about my bike and I strongly believe he stole it for his personal benefit and my bike is still on Emi. I fear if he stole it to sale it or he is using it for some illegal activities.

I hereby, request you to kindly investigate into this matter and take necessary legal action against the said Bablu Kumar Sha.
