Sir,

In producing herewith three (04) accused persons namely (i) Sagar Tamang (27) S/O Lt. Abishek Tamang of Rambi 29th Mile, PS Rambi, Dist Kalimpong, (ii) Kamal Ray (20) S/O Bablu Ray of Tulshi Nagar, near Thokkar Bridge, PS Matigara, Dist Darjeeling, (iii) Subham Biswakarma (21) S/O Lt. Padam Biswakarma of Tista Bazar, PS+Dist Kalimpong, and (iv) Sunil Tamang @ Chepe (30) s/o Shankar Tamang of Sishudangi, Milanmore, PS Pradhannagar, Darjeeling, under arrest and the following articles under seizure viz :- (i) 01 (one) iron made Crow bar, approx measuring 24 inches, ii) One iron made Chisel approx measuring 18 inches iii) one hammer with wooden handle approx measuring 10 inches, iv) one iron made sword with wooden hendel measuring 28 inches, v) one black & blue colour tourch light and (vi) one multi colour nylon carrying bag.

I, SI Rajiv Subba of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted four (04) arrested accused persons and others 06/07 unknown miscreants who involve in this crime to the effect that on 10.04.2025 at 00.35 hrs I received a specific source information that about 09/10 miscreants equipped with deadly weapons assembled at Public bus entry gate, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and they are preparations for committing Dacoity at Siliguri Junction and its surrounding area.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 472 dated 10.04.2025 and as per your kind order and direction myself accompanied with SI Goutam Mallik, ASI Biplab Kr. Das, and force all of Pradhan Nagar PS, SPC left for Siliguri Junction, PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. On the way, I informed videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel road, Arabinda Pally, PS- Siliguri, Dist. Darjeeling over mobile phone and requested him to come to Siliguri Junction with his video Camera for the purpose of Videography if required. I also informed night RT K-30 van officer ASI Jaggannath Roy of Pradhan Nagar PS and directed him to come to Siliguri Junction to accompany us. At around 01.05 hrs we arrived at Siliguri Junction, and after a while R.T. van officer ASI Jaggannath Roy arrived there. I shared the information with them and briefed them properly. Then, I contacted with my source and from a considerable distance he pointed the place i,e public bus entry gate, Siliguri Junction where we noticed a suspicious movement of group of miscreants. Then, I contact with two independent witnesses namely (i) Sumit Kumar Yadav S/O Kashinath Yadav of Gurung Busty, PS Pradhannagar Darjeeling and (ii) Dipak Dey S/O Lt. Subash Dey of Ramkrishna Colony, ward No. 47, P.S. Pradhn Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. At around 01.15 hrs the above mentioned video grapher arrived at the spot accordingly he also brifed throughly.

Thereafter, we proceeded towards public entry gate of Siliguri Junction and cordoned the place from every corner with due care and cautioned and from a considerable distance we noticed that some persons were assembled at front of public gate of Siligur Junction and they were whispering in a low voice, the movement of those persons were very suspicious. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted 04 (four) accused persons while 06/07 others unknown miscreants managed to fled away from the spot, taking the advantage of darkness. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted articles (house break weapon as well sharp cutting weapons) from their joint possession which was they kept conceal inside a multi colour nylon carrying bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparation for committing Dacoity at Siliguri Junction and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 01.20 hrs to 01.55 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of video graphy executed by the above mentioned videographer as per norms of BNSS and brought all the 04 arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted 04 accused persons along with theirs others associeates (who managed to fled away) assembled there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Siliguri Junction and its surrounding area.

Under the above circumstances, I pray before you that a specific case against may kindly be started against the accused persons namely i) Sagar Tamang (27) S/O Lt. Abishek Tamang of Rambi 29th Mile, PS Rambi, Dist Kalimpong, (ii) Kamal Ray (20) S/O Bablu Ray of Tulshi Nagar, near Thokkar Bridge, PS Matigara, Dist Darjeeling, (iii) Subham Biswakarma (21) S/O Lt. Padam Biswakarma of Tista Bazar, PS+Dist Kalimpong, and (iv) Sunil Tamang @ Chepe (30) s/o Shankar Tamang of Sishudangi, Milanmore, PS Pradhannagar, Darjeeling, and others 06/07 unknown miscreants under proper section of law and arrange for its investigation.
