Dear Sir,

With due respect I beg to submit you the followings as under:-

- (i) That I have entered in to an agreement dated 12.12.2024 with Sri Bishwamitra Roy in respect of the landed property measuring .33 acre appertaining to R.S. Khatian No. 574 being part of R.S. Plot no. 30 corresponding to L.R. Plot No.130, Sheet No. 18, Mouza Binnaguri. Copy of Agreement is enclosed hertewith for your kind perusal.
- (ii) That in the said agreement he has agreed to handover the possession of the aforesaid landed property to me but after receiving the sum of Rs.15,00,000/- (Rupees fifteen lakhs) only from me in the presence of his sons namely, Khirod Roy and Chand mohan Roy on 12.12.2024 he failed to handover the possession of the aforesaid landed property to me till date and thereby cheated me and misappropriated my fund with malafide intention.
- (iii) That Sri Bishwamitra Roy has entered in to the said agreement with malafide intention to defraud me with the said sum of Rs. 15,00,000/-9Rupees fifteen lakhs) only in collusion with his aforesaid sons namely, Khirod Roy and Chand Mohan Roy and are liable to be punished under the provisions of law.

As such, you are requested to take appropriate action under the provisions of law against the aforesaid persons and oblige.
