I Sri Anirban Mondal, S/o Sri Prabir Mandal being the Manger of the Star Hospital, Tinbatti More, Siliguri, Police Station: New Jalpaiguri, Post Office: Sevoke Road , District: Jalpaiguri-734005, do hereby inform you that one Miss Papiya Sarkar, aged about 24 years was admitted to our hospital on 28th March 2025 in serious condition and there after she was attended by Dr. Sayed Khizar, Neuro surgeon followed by a surgery. Unfortunately, on 2nd April 2025 inspite of best efforts and treatments provided to Miss Papiya Sarkar, she expired. Follwed by the said incident on the fateful night when patient Miss Papiya Sarkar expired, several persons along with 1) Sunita Das, daughter of Sushila Das, resident of Tinbatti Colony, Bhaktinagar, Siliguri, District: Jalpaiguri, 734007, 2) Shalini Ghosh, daughter of Sujit Ghosh, resident of New Township, Kauakhali, Siliguri, District: Darjeeling, 734012,3) Sulagna Paul, daughter of Nitai Paul, resident of Shaktigarh, Road No.12, Siliguri Bazar, Ward No.31 of S.M.C, Siliguri Bazar, Jalpaiguri, 734005 were present at our hospital and the aforesaid persons along with others without any rhymes and reasons started created chaos inside the hospital premises and threaten the doctors and staffs of the hospital with dire consequences. All throughout the aforesaid persons were instigating the relatives of the deceased patient to create ruckus at the hospital and not to pay the requisite bill amount incurred by the hospital for the treatment of the deceased patient. All the acts of the aforesaid persons were recorded in the CCTV available at the hospital premises and their acts created hindrance in the smooth running of the hospital, treatment of the patients admitted at the hospital. The aforesaid persons for quite a long time created a hostage like situation inside the hospital premises, thereby restricting the movements of the hospital staffs, nurses and other medical staffs.
