I, Sri Raju Biswas, Son of Late Amulya Kanti Biswas, resident of Siliguri Junction, Pati Colony, Ward No. 47 of SMC, that I have been working under AADYA CONSTRUCTION, a partnership firm, having its office at Asmi Kunj, Block-B, Jatin Das Sarani By Lane, Ashrampara, Siliguri and I have been appointed as a site supervisor in a construction site at Saradamani Road, Ashrampara, Near Kali Mandir, Post Office – Siliguri, Pin-734001, Dist. Darjeeling, ward No. 14 of Siliguri Municipal Corporation.

I have gone today on 11-04-2025 at 5 P.M to visit the site when a person namely Sri Bikram Halder, Son of Bidhan Halder, resident of Durga Das Banerjee Road, Ashrampara, Siliguri who is carrying some anti-social activities in the area came to the said construction site on his motorcycle and asked me for money as extortion regarding the supply of sand, stone in the said construction site. When I refused to talk to him and deny him any money, he attacked me with a sharp knife unnecessary without any cause and when I tried to stop him, he has beaten me brutally and tried to kill me by choking me. The nearby people came for my help and saved me from the goon.

Today on 12-04-2025 at morning when I was coming to my work he threatened me again at Junction More near my house that if I come to work he will again attack me with dire consequences.

I have been visiting the site for a long time; now after the incident I am very much terrified as the said goon also threatens to kill me whenever he will see me on the road and I fear for life as I am only earning member of my family and I need to do work in the said area to survive my livelihood.

This is very unfortunate to say during daylight such anti-social goon roaming free in the area and attack me at the construction site and threatens everyone who ever trying to stop him.

I would request you to save me from the said goon and take strict actions against such goon and criminal activities as he is disrupting the peace of the nearby society and also hampering serviceman like me.

Therefore I request you to kindly look into the matter as the criminal activities and goons in the area growing day by day and I will be highly obliged to you.
