Amir came out from our house and told them no to drink in front of our house then they told that if you have any problem then go to Pakistan or Bangladesh, this is not your place and if you have to live here then converted in Hindu religion and speak loudly Jai Shree Ram, after that my son asked why they bring religion issue in this matter then they with out any reason started using filthy languages and when my son Md. Amir defend them they started kick my son in his stomach and also beat my son here and there and they also hit my son's head with bamboo sticks, after hearing my son's shouting when we came out ,the above mentioned accused persons fled away. Then with the help of the local people we take my son to the district hospital and there he got hospitalized and his treatment is going on.

Therefore I request you please look into this matter as soon as possible and take proper legal action against this illegal activities as because we live in peaceful city Siliguri where every religion people live like brothers and this kind of anti-religious statement can create a big issue in our city.
