Sir,

In producing herewith the following seized articles as per seizure list viz :- (i) One vehicle (Swaraj 963FE- Tractor) having registration number WB-71-B-6452 loaded with illegal river bed materials and (ii) 03 numbers of shovels. I, ASI Biplab Kr Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the driver and owner of the above mentioned seized vehicle having registration number WB-71-B-6452 to the effect that today on 11.04.25 at around 05.15 hrs, I received a specific source information that illegal mining of river beds materials is going on Mahananda river bed at Military Ghat under Pradhan Nagar P.S. Dist. Darjeeling and the owner and drivers loaded river beds materials illegally in their trucks to sell the same to their design customers for their illegal gain. Accordingly, I diarized the matter in PS General Diary vide Pradhan Nagar PS GDE No. 537 dated 11.04.2025 and informed the matter to you and as per your kind order and direction myself accompanied by SI Goutam Mallik, SI Rajib Subba, SI Bandhan Roy and force left for Mahananda river bed, Military Ghat to verify the veracity of the information by Govt. Vehicle.

At around 05.45 hrs we reached at Military Ghat, Mahananda river bed and from a considerable distance we noticed that seeing our police van one tractor trying to flee away from Military Ghat. We chase the vehicle but driver of the said vehicle flee away keeping the vehicle on river bed. We tried to apprehend the driver of the said tractor but in vain. After arrival we found that the said tractor loaded with illegal river bed materials. We searched the driver and owner of the said vehicle (Tractor) having Registration number WB-71-B-6452 but found absconding. During enquiry it could be revealed that the owner and driver of the said vehicle mines river bed materials from Mahananda rivar by illegal means and loaded the same in the vehicle to sale the same to their design customers for their illegal gain. Accordingly, I seized the above mentioned vehicle (Tractor) having registration number WB-71-B-6452 loaded with illegal river bed materials under proper seizure list from the spot under section 106 BNSS. The entire process of search and seizure was made under the coverage of videography in between 06.25 hrs to 06.50 hrs as per norms of BNSS and brought to Pradhan Nagar PS/SPC for further investigation.

Under the above circumstances, I, pray before you that a specific case under proper section of law may kindly be started against the owner and driver of vehicle having registration number WB-71-B-6452 and arrange for its investigation.
