I Dipika Gupta, d/o- Banarashi Prasad Gupta, r/o- Gurung
Busti, w/No-3, P.O. P.P- Pradhan Nagar, Dist- Darjeeling write you
this F.I.R to bring you notice that on 10/04/25 at around 4:00 pm
my brother namely Mukesh Gupta, s/o- Banarashi Prasad Gupta
suddenly suddenly approached to my minor daughter and started
assaulting her, by seeing that I approached to my brother and
asked him why he assault my daughter, by asking that
my brother also started assaulting me brutally with bamboo,
stick, brick, kick, punch and grab my hair and pull and
hit my head on the wall and also kick on my stomach, and
also threatened me if I went to police station he will cut
my daughter into pieces and also kill me whenever he get the
chance and also not allow us to enter the house. By seeing
the incident my neighbour approached and rescued me from his
hand and my mother took me to the Siliguri District Hospital
for medical attention.

With this incident I am in a great fear and
found no other way came before your office to take immediate
strict legal action against my above named brother namely
Mukesh Gupta.
