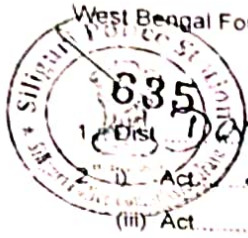

Sub: Complaint for theft in my Flat.

Sir

I am writing to report a theft that occurred in my flat 2A, Ajanta Tower 1st Floor, Lenin Sarani, Deshbandhupara, Siliguri, Darjeeling- 734004 in board daylight on 12/04/2025 when me and my family went to my daughter's school for parents teacher meeting. We left the flat at about 12.15 pm and return back at about 4.30 pm. During this period of time some unknown miscreants broke into my said flat by braking the locks of collapsible gate and front door. The miscreants (thieves) had been burgled my said flat and taken away all my valuable belongings like gold and silver jewellery, utensils, watches and cash by braking the locks of 2 inside lockers of steel almirah and 4 wooden almirahs where the items are kept.

I don't have any information about the suspects in this time. I would request you that CC camera footage may be collected from adjacent houses and apartments as there are no CC cameras installed in our apartment as yet.

Therefore, I request you kindly to register an FIR to take necessary action to investigate the matter and recover items.
