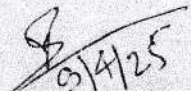
Sub: Regarding unauthorized construction of sausage wall over River Lachka under Gossainpur GP.

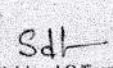

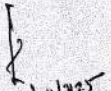
