Subject: - Report of a Hit and Run Accident on
April 8, 2025, at Champasani Main Road,
Connecting to Eranesh Ghosh colony Road,
Near:- Circuit house traffic point

Dear Sir,

I'm writing to report of a Hit and Run Accident
that occurred on April 8, 2025, between 3:20 pm and 4:00 pm
near Circuit house traffic point, opposite of the Shiv Mandir.

I was crossing the Road on my way to Pradhan
Nagar when a Royal Enfield bike overtook a Car and
hit me severely, causing a deep long cut on my Right
leg from Knee to Ankle and inner injuries in several
parts of my body.

The bike rider fled the scene without helping. A
Woman from a nearby vegetable shop came to my aid and
after few minutes a kind stranger took me to Siliguri
Civil hospital, Near Court More. I received 33 stitches on
my right leg. The doctor admitted me to the hospital due to
severe injuries, pain and bleeding. Where I was admitted
till the evening of 10th April 2025. I couldn't note
the bike's number plate due to pain but I can describe
the rider's face and bike colour.

There are two CCTV points near the accident.

spot, and the vegetable shop owners witnessed the incident. They may provide valuable information. As the sole earning member of my joint family, consisting 8 members, my hospitalization has caused significant distress. I

I request immediate action to indentify the bike rider using cctv footage and witness statements and ensure justice is served. Due to treatment Reasons delay in filling the complaint.
