Subject: FIR/Complaint Regarding physical attacks

Respected Sir,

I, Miss. Radha Gurung, Daughter of Pramila Yolmo working for gain at Amarbhoomi Private Limited, Near Maa Mahalaxmi Dharm Kanta, Easter By Pass, Post Office - Bhaktinagar, Police Station - Ashighar Phari, District - Jalpaiguri, am writing to bring a serious matter to your attention that occurred on 12/04/2025 at around 16:00.

One Swapan Roy, son of Prafulla Roy (Mob No. 74776-96976) who was driver of Amarbhoomi Private Limited without informing to me or any other concerned person stopped coming to work for the company from 7th of April, 2025. thereafter suddenly came to office today at around 16:30 pm to quarrel about his absconding period to be forgiven and when asked for office mobile to be submitted which was stolen by him he very rudely started misbehaving with me with filthy languages and pushed me then our sir Arnav Singh Raizada who came to my defence led to physical attacks by Swapan Roy, bleeding through skin brutally of Arnav Singh Raizada. Once again when i tried to stop Swapan Roy and his wife from doing such type of illegal acts and activities he once again physically assaulted me and tried to disrobe my modesty due to which i got bruises upon my person. Thereafter we immediately rushed to Siliguri District Hospital and got our medical done by the concerned medical officer (medical documents enclosed).

This incident has caused us a great deal of distress and anxiety to me as a woman, and I firmly believe it is in the public interest that this issue is dealt with appropriately to ensure such an event doesn't recur. Therefore, I kindly request you to take immediate action against those involved.

I would greatly appreciate your immediate attention to investigate into this matter and take strict legal actions against Sri Swapan Roy and his wife as per appropriate sections of law and put the wrongdoers behind bar. Thank you for your service and your dedication to maintaining peace and order in our community.
