I Would Like To State That My Father Habibullah Sheikh Residing At C/O Akbar Ali, Vill- Kamrangaguri, Near Kabaristan , P.O- Sattelite Township , Pin – 734015, Dist-Jalpaiguri, Ph No- 8906830775. And My Brother Khalilullah Sheikh Residing at Amrapally Apt. Near Don Bosco School Flat No A5, Siliguri, 734001, Ph No - 6295994866 . Both are harrasing me just for the sake of my mother's land . My father acquires more than value of Rupees 20 Crores Property In Siliguri & Jalpaiguri , which is solely in my father's name and only my brother's name . We are five sisters and one younger brother and my mother Died On 23/10/2009. Just one month before the demise of my mother without our knowledge my father fraudly made a fake gift deed between my mother Mahenur Begam and brother Khalilullah Sheikh who was a minor (13 years) at the time of fake give deed execution and there is no guardian mention in fake gift deed in place of acceptance.

As my mother was at the last stage of cancer and she was not in a sound mind. My father killed my mother without giving proper and basic treatment instead of having so much money and land, he use to delay her treatment and went through N.F. Railway and torture her. To save his money no private treatments she had been taken because of my greedy father and he married within a year of mother demise because he had an affair with my step mother. Even my father forged my elder sister Tabassum Parveen signature as the first witness and name is also wrong and not signed by her and Her pan card is also attached.

On 6<sup>th</sup> Jan 2025 there was severe fight between Habibullah Sheikh and his son Khalilullah Sheikh about land and they both hit each other with fist and blows just near our land on road side Jorpakhri and they both lodged fir against each other. Even Khalilullah Sheikh complained against his father On N.F. Railway as he is retired C.T.I, and Khalilullah Sheikh did not mention Habibullah Sheikh as his father and only mentioned mother's name every were in complain which is attached, because of their fight we came to know that they both are cheating their own daughters and sisters just for that sake of land and selling my mother's entire properties to the land mafias named Ranjit Kumar Srivastav who is land broker Ph No- 9434045072. As i have filed civil suit against them for cancellation of deed, My Father Habibullah Sheikh and my brother Md. Khalilullah Sheikh both has started threatening me and abusing me and my sisters about our character as well and even my father started calling my husband and in-laws and creating misunderstanding between us, because of my father now a day's my in-laws and my husband misbehaving with me and taunting me all day.

I came all the way from Malda just to talk to my father and brother On 25/03/25 at 5 am by train to make them understand that i am having suicidal tendency just because of my fathers and brothers greedy mind and also he forged our signatures in several of his deeds. Yesterday On 25/03/25 around 1:30 pm when court has appointed land surveyor to check the position of land, I along with my sisters was also present there. As soon as land surveyor was gone my father and brother started abusing me in every bad manner and my brother hit me on my chest and my father twisted my hand and pushed me on the ground by hitting on my leg and continuously threatening me to take back cases so that they can sale the land. On 2015 my father and brother took Rs 17 Lakhs from my elder sisters husband Siddique Shahadat S/O Shahadat Hosain residing at Hakimpara Siliguri, Ph No- 9832654763, against 10 katha Land at Jorpakhri for Md. Khalilullah Sheikh educations and well being and my father signed agreement as well. Later we came to know that Md. Khalilullah sheikh fake the neet entrance exam by the influence of hefty amount of money and we have file R.T.I against Md. Khalilullah Sheikh.

Since the day i am married i have not taken a single penny from my father and not any of my sisters has any relation with my father because of his greediness. My advocate Ram Pravesh Roy Ph No-9832091593 has also cheated me as we didn't knew that he is a good friend of my father due to his influence advocate Ram Pravesh Roy didn't mention any points as per our conversation and when i protested the lawyer to give back all my original documents and dummy plain blank sheet in which he has taken our signature in more than 100 papers and we have also complained in Jalpaiguri bar council as well as against him. My father and brother are very greedy and criminal minded and can lead to physical and mental damage for me.

As we have full faith on judiciary system, so kindly take appropriate action against Inspector-inspector themosther wish in future they will be more harmful for the society .
