I SI (AB) Bivash Adhikary of Jalpaiguri Traffic Guard, SPC beg to lodge a written complaint against accused namely Sourav Sahani (22yrs), Male, S/O- Sankar Sahani of Rajahowli, NJP, Bhaktinagar, Jalpaiguri to the effect that on 16.04.2025 at about 11.45 hrs while performing traffic regulation duty along with Const/1136 Bibekananda Paul and CV-241 Raju Das at Tikiya Para More area at that time the above noted person came before me by riding motor cycle bearing reg. number- WB74AF-3841(Black Colour) and resistance me for performing govt. duty. I directed him to go away from Tikiya Para more area, but he started to threaten me and abused with filthy language. There after local person and on duty police personnel apprehended him and inform to Sigma (traffic control room) and handed over the above noted accused person and the motor cycle having reg. no. WB74AF-3841 to the Van officer.

I, therefore, pray before your honour started a specific case under proper section of law.
