Sir,

I, Smt. Barnali Paul, Wife of Sri. Sanjib Sarkar, Daughter of Late Balaram Paul, presently residing at 15A, Gobra Gorosthan Road, Gobinda Kartick Road, Police Station Tangra, Kolkata-700046 and presently residing at C/O Ranjit Mondal, Sulangori Colony, Near Sulangori High School, (Near Dhali Bridge) Post Office Sulangori, Police Station New Town, Kolkata 700059, District 24 Parganas North, beg to draw your kind attention

That on 04.02.2014 my marriage was solemnized with Sri. Sanjib Sarkar, Son of Sri. Gopal Sarkar residing at Kalpana Dutta Lane, North Bharat Nagar, Near Tiger Sporting Club, Ward No. 24, Post Office Rabindra Sarani, Police Station Siliguri, Pin No. 734006, District Darjeeling according to Hindu Rites and Customs at my parental house.

That That at the time of solemnization of the aforesaid marriage my parents and my parental relatives provided huge numbers of gifts and my parents organized the said marriage lavishly and make all sorts of arrangements as up to their capacity.

That after the solemnization of the aforesaid marriage I went to my matrimonial home at Kalpana Dutta Lane, North Bharat Nagar, Near Tiger Sporting Club, Ward No. 24, Post Office Rabindra Sarani, Police Station Siliguri. Pin No. 734006. District - Darjeeling and I started to reside in my matrimonial home as husband and wife and our said marriage was duly consummated.

That subsequent to the solemnization of my aforesaid marriage I spend my time more or less happily for about 5 (Five) years and whatever had happened has been adjusted with mutual understanding.

That just after passing of 5 (five) years situation started to change gradually and my husband started to misbehave my me in every trifling matters and with the progress of time I came to know that my husband is maintaining an illicit relationship with one lady (name is not properly known to me).

That on raising strong objection against such behaviour my husband become so arrogant and started to misbehave with me and also started to

abuse me with filthy languages which become unbearable day by day. It is worth to mention herein that my husband is an habitual drunker and he used to come late at night in such drunken condition and used to abuse me and assault me mercilessly.

That due to the said situation I informed the said incident to my parents and maternal uncle and all of them intervened into the matter and also negotiate with my husband and also with my in-laws. It is worth to mention herein that my in-laws replied that such incidents are quite common and it can happens and it is better to ignore for having a happy and peaceful conjugal life.

That after such negotiation my husband apparently stopped misbehaving with e for about 3 (Three) months and after completion of the aforesaid period of three months his behaviours again changed and he again started to misbehave with me and also started to abuse me and make my life miserable.

It is pertinent to mention herein that my husband again started to keep the illicit relationship with the said lady and he was so reluctant regarding the welfare, maintenance and love and affection towards me.

It is to be mention herein that I have tried to adjust myself with the aforesaid situation in order to keep peace in the family and also for my security but nothing has happened and my husband keeps on doing the such behaviour and also ignored me in every possible manner.

That during this period I came to know that I am having the ovarian cyst in left side and doctor advised me to take baby through IVF procedure but very unfortunately due to expense my husband refused to avail that procedure and started to humiliate me in every possible manner. It is worth to mention herein that my in-laws also did not give any support to me and caused be serious mental agony.

That due to increase of mental torture I was compelled to leave my matrimonial home in the Month of December, 2022 and took shelter in my parental home under the case and custody of my parents. That in the mean time my parents tried a lot to solve the dispute and for having a happy and peaceful conjugal life and after joint negotiation my husband came to my parental home at 15A, Gobra Gorosthan Road, Gobinda Kartick Road, Police Station Tangra, Kolkata 700046 and after staying for about three days my husband took me to my matrimonial home at Kalpana Dutta Lane, North

Bharat Nagar, Near Tiger Sporting Club, Ward No. 24, Post Office Rabindra Sarani, Police Station Siliguri, Pin No. 734006, District - Darjeeling.

That it is very sad to mention herein that again my husband started to create dispute and disturbance with me and also started to abuse me and also to neglect me in every possible manner and also did not provide any maintenance to me. That during this point of time I started to realize that it become quite impossible to stay with my husband in my matrimonial home and ultimately due to immense mental and physical torture I left my matrimonial home in the month of July, 2023 and started to stay in my parental home at 15A, Gobra Gorosthan Road, Gobinda Kartick Road, Police Station Tangra, Kolkata 700046 under the care and custody of my parents.

That it is very surprisingly and also unfortunate to say that my husband is a business man by profession and doing the distributor business of lemon and water melon and orange farming and also involve in the export of those items in foreign countries and thereby he earns near about 1,50,000/- to 2,00,000/- per months but in spite of the aforesaid my husband did not provide any maintenance and ignored me in every possible manner.

That on 01.03.2025 at about 10.00am my husband together with some unknown miscreants went to my residence and tried to abduct me with an ill-intention, I protested against their activities as a result of which they used filthy languages towards me and my husband assaulted me by fist, blows and lathi, ultimately they left from the said place, but they threatened me that they would come again and abducted me from my residence, after the said incident I became shocked mentally as a result of which I am not in a position to appear physically before your authority and I am sending this complaint through speed post.

I am requesting you to treat the same as FIR and investigate the matter in accordance with law.
