1. That the complainant company, m/s. Bata India Ltd is a
Public Limited company, duly incorporated under the Companies
Act, 1913 having its Registered office at 27-B, 1st floor, Camac
Street, Kolkata 700016 and corporate office at Bata India Ltd,
milestone, Ecodia centre, 2nd floor, Sector 15, Part-II, Gurgaon,
Haryana 122001. Besides various manufacturing facilities and retail
network/shops/stores all-over India, The complainant is the owner and
Licensee of various legendary Brands such as Bata, Road, North-
Star, Bubble Gum, Marie Claire, Weinbrenner, Naturalizer,
Hush, Puppies, Dr. Scholl, Sunshine, Sundak, Ambassadors to name
a few. The complainant company is dealing in manufacturing, mar-
keting and sale of footwear and accessories and known in the
field of business for its honesty, punctuality as well as quality.

That complainant company has one of its retail store (store
code-523) at Siliguri Hill Cart Road. On 15.04.2025 (Tuesday)
night, some miscreants have stolen away A/C (Air Conditioner)
Pipe copper wire (approximately 15 meters) from our store's outside

Wall which is located at Bata store, Neel Kamal Shopping Plaza, opposite to Meghdoot Cinema Hall, Hill Cart Road, Siliguri, Darjeeling West Bengal - 734001.

2. That we are anticipating the loss amount of our store said stock due to theft by the unknown miscreants approximately Rs. 17000 (Seventeen thousand) and we can ascertain that exact loss after completion of the inspection.

3. That since the aforesaid acts of the unknown miscreants constitute serious offenses that are punishable under law and are cognizable in nature and falling under the jurisdiction of this Authority for lodging an FIR and taking appropriate penal action against the unknown miscreants as per the provision of law.

4. That the unknown accused persons those are involved in serious offences like theft are looming large in the public, posing serious threat to the general public and society at large and kindly do the needful at the earliest by registering the offence as FIR in the instant matter and investigation the same at the earliest.
