With due respect I Sankar Sarkar, son of Late. Narendra Nath Sarkar, residing at B.B.D Sarani by lane, Haiderpara, P.O- Haiderpara, P.S. Bhaktinagar, Dist- Jalpaiguri, Pin-734006, being the authorized representative of Tarai Foundry Works Pvt. Ltd. having registered office at Plot No.10, Siliguri Industrial Estate 2<sup>nd</sup> Mile, Sevoke road Siliguri, District- Jalpaiguri, PIN- 734001 would like to inform you that on 17-04-2025, 8.30 AM when our electrician Anil Karar, came to our Electric Workshop situated in our factory premises, he was inspecting the Electric meter and electronic goods. Unfortunately, he was shocked to find that Copper Coil 09(Nine) Pcs was missing from our Electric workshop which is approximately of Rs.10,000/-[(Rupees Ten thousand)only]. After necessary inspection and searches, it is ultimately revealed from our CCTV footage, that a man in a yellow full sleeve t-shirt entered our factory premises on 12.04.2025 at about 11.37 AM. After entering he went to one of our factory worker and asked him if there is any work for him or not. As our factory worker refused him any available work, he turned back to exit our factory. Before exiting the front gate, he discreetly entered into our Electric workshop which is just near the factory gate. Upon entering, he stole Copper Coil 09(Nine) Pcs worth approximately Rs.10,000/-[(Rupees Ten thousand) After stealing, he fled away on his bicycle, which is evident from the CCTV footage. This is enclosed herewith in a SanDisk Cruzer blade USB drive bearing No. BM250158425W.

We therefore request you to register this Complaint, initiate appropriate investigation to identify and apprehend the person whose facial identity is revealed in the video footage. We would also request you to recover the Copper Coil from him. We are ready to cooperate and provide any further information as required. Your early action in this regard is highly solicited.
