THREAT, EXTORTION, CHEATING, DISHONESTY AND
CRIMINAL BREACH OF TRUST BY SRI SUJIT
MALICK, SON OF NARAHARI MALICK,
RESIDENT OF NETAJI COLONY, BATTALA,
JAGABANDHU ASHRAM, POST OFFICE
GHOGOMALI, POLICE STATION BHAKTINAGAR,
DISTRICT JALPAIGURI, PIN 734006 AND HIS
WIFE NAME NOT KNOWN.

Respected Sir

This is a humble attempt to bring to your august office's notice, the Cheating, dishonesty, reluctant, illegal approach undertaken by Sri Sujit Mallick, son of Narahari Mallick, resident of Netaji Colony, Battala, Jagabandhu Ashram, Post Office Ghogomali, Police Station Bhaktinagar, District Jalpaiguri, PIN 734006 in the state of West Bengal and his wife.

Brief facts leading to redress my grievances before you as and by way of my present complaint is stated herein below for the sake of your ready reference and perusal and also to enable you to effectively and efficaciously take appropriate actions in the present matter.

With profound respect and humble submission that I, Joydip Kar,

son of Shri Pramodh Kar, resident of Jagat Bandhu Ashram Road, Netaji Colony, ward No. 37 of S.M.C, Post Office Ghogomali, Police Station Bhaktinagar, District Jalpaiguri, PIN 734006 in the state of West Bengal would like to state before you that I and my wife had jointly agreed to purchase a land measuring about 1.5 Katha which is recorded in L.R. Khatian No.310, appertaining to and forming part of L.R. Plot No.187, situated within Mouza Dabgram, Sheet No.93, J.L. No.2, Police Station Rajganj now Bhaktinagar, District Jalpaiguri in the State of West Bengal [hereinafter referred to as the Schedule property for the sake of brevity].

That myself and my wife agreed to purchase the scheduled property from Shri Sujit Mallick at a price of Rs.30,000,00.00 [Rupees Thirty Lakh] only and we have paid the said sum of money partly through NEFT and partly in cash between 12.09.2023 to 02.02.2024 and Shri Sujit Mallick duly acknowledged the payment of the consideration amount paid by executing an agreement and acknowledging the Total consideration amount paid by putting his signature. That after full and final payment of the consideration amount the said agreement for sale duly notarized before the Notary Public, Siliguri dated 06.02.2024.

That as per the said agreement for sale said Sujit Mallick is bound to execute the sale deed in respect of the schedule property to and in favour of myself and my wife as such we approached him personally to fix the date of registration of sale deed but he is/was neglecting/avoiding us to execute the same but finding no other way I and my wife issued a demand notice dated 13.01.2025 through our engaged advocate and after the receiving of the said notice said Shri Sujit Mallick threatened me with dire consequences that he will not sell the schedule property to me and my wife and try to grab my hard earn money which I and my

wife have paid him as a full and final consideration amount i.e. a sum of Rs. 30,00,000.00 [Rupees Thirty Lakh] only duly received by him and when I visited his house he pushed me out from his house and warned me if I again visit in his house to redress my grievances he will make all possible attempts to kill me.

That now I am forced to believe that said Sujit Mallick dishonestly induced myself and my wife by entering into the said agreement for sale just to grab the consideration amount of Rs.30,00,000.00 [Rupees Thirty Lakh] only and have deliberately cheated us.

That I am at present in a great apprehension of loss of my life in the hands of said Sri Sujit Mallick along with his wife and their other men and agent if I asked my hard earned money from them in their said illegal acts and activities.

That the culprit i.e. Sri Sujit Mallick along-with his wife and their other men and agent have been constantly threatening me and trying to grab my hard earn money and pressurizing me under the garb of settling the personal score as accused can go any extent to meet their goal. If no penal and appropriate lawful action is initiated against the culprits, the said culprits may follow the same modus operendi to do more offences in future with some other person/s who are vulnerable towards such illegal actions. That the culprits have even threatened to implicate me and my family members in false cases in future if we take steps to recover the amount paid to him.

Under such circumstances I hereby lodge this complaint against said Sri Sujit Mallick along-with his wife and their other men and agent and would request you to take necessary step as against them so that the said money grabbers are unable to pursue their illegal and nefarious act.

I sincerely hope that your August Office would consider my present situation in the light of interests of justice, Compassion and urgency and take necessary steps for the safeguard of my life and safeguard my hard earn money as the miscreants who have threatening to kill me and can go to any extent to harm myself and as well as my family.


