In producing herewith following four accused persons namely 1) Ranjit Oraon-33yrs s/o Lt Jhari Oraono Shibnagar Manasa mandir, PS Bhaktinagar Dist Jalpaiguri (2) Tapas Roy-25yrs s/o Banamali Roy of Shibnagar Manasa mandir, PS Bhaktinagar Dist Jalpaiguri and (3) Manik Roy-23yrs s/o Somesh Roy of Shibnagar Manasa mandir, PS Bhaktinagar Dist Jalpaiguri with following seized articles viz:

1) One Iron made adjustable wrench measuring approx 8" recovered from the exclusive

and conscious possession of Tapas Roy

2) One iron made screwdriver measuring approx 18 inches recovered from the exclusive and Conscious possession of Manik Roy

3) One iron made hammer length approx 10 inches recovered from the exclusive and conscious possession of Ranjit Oraon

I, ASI Dhruba Misra s/o Abani Misra of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above accused persons and 6/7 others to the effect that on 19.04.25 at 00:10 hrs received a specific source information that 10/11 miscreants have assembled at fauji math, Limbu Busty under BhaktiNagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 865 dated 19.04.2025 and as per order I along with SI Srimanta Chatterjee, SI Yuel Lepcha, ASI Khagen Barman, ASI Amal Barman and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for fauji math Limbu Busty under Bhakti Nagar PS, to work out the information in hand vide Bhaktinagar PS GDE No-866 dated 19.04.25..

At about 00.25 hrs we reached at fauji math Limbu Busty being indicated by the source we noticed that 10/11 persons were assembled at fauji math Limbu Busty under Bhakti Nagar PS, and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we police party somehow managed to apprehended above noted 03 (three) of them with deadly weapons in their possession but 6/7 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

BEN 1981 SPE 4+19:04.2025 On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 19.04.25 in between 00.55 hrs and 01.25 hrs. The whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 1) Ranjit Oraon-33yrs s/o Lt Jhari Oraono Shibnagar Manasa mandir, PS Bhaktinagar Dist Jalpaiguri (2) Tapas Roy-25yrs s/o Banamali Roy of Shibnagar Manasa mandir, PS Bhaktinagar Dist Jalpaiguri and (3) Manik Roy-23yrs s/o Somesh Roy of Shibnagar Manasa mandir, PS Bhaktinagar Dist Jalpaiguri and others kindly arrange for its investigation
