As mentioned in above subject, I am writing to report a theft of electrical cables from our site, which is located at Siliguri Town. Despite our previous intimation through a General Diary entry, the theft has continued, and significant quantities of cables have been stolen over the past few days.

Details of the stolen materials:

- **Type of Stolen Materials:** 33KV 3CX400 Sqmm Cable, 11KV 3CX300 Sqmm Cable, 1.1KV 4CX300 Sqmm Cable, 40mm PLB Duct Pipe
- **Locations & Lengths of Stolen Materials:** At various Locations such as Burdawan Road Near Golden Plaza & Overall under construction ROB Area, Hill Cart Road (Guinea House Near Khadim's & Shraddha the Cosmetic Shop) and Dangipara Area.
(Total Stolen Cable & Pipe Lengths are Approx 65 Mtr of 3CX400 Sqmm, 135 Mtr of 3CX300 Sqmm, 25 Mtr of 4CX300 Sqmm, 300 Mtr of 40mm PLB Duct Pipe Roll)

I request that you register a FIR and take necessary action to investigate this matter, apprehend the culprits, and help us to recover the stolen materials.
