Goutam Barman, Coal Depo, Ward No 07 of SMC, PS-Siliguri, Dist-Darjeeling (Not verified) under arrest along with the following seized articles:-

- 1 01 (one) steel made rod measuring approx. 85 cm in length which was found on the right hand of the accused person namely Md. Azmat (M/24 years) S/O-Md. Matiullah of Kholaibaktori, Tulsinagar, PS-Matigara, Dist-Darjeeling.

- 4 01 (one) iron made sword measuring approx. 70 cm in length including its iron made butt found on the right hand of the accused person namely Ajay Barman (M/20 years) S/O-Lt. Goutam Barman, Coal Depo, Ward No 07 of SMC, PS-Siliguri, Dist-Darjeeling

I, SI Chiranjit Saha, s/o-Madhab Saha of Khalpara TOP under Siliguri Police Station/SPC would like to lodge this written complaint against the above noted persons and 05/06 (five/six) other accused persons to the effect that today i.e. on 20.04.2025 at about 01.45 hours received a secret source information that a group of 09/10 persons had assembled at Jalpaimore Kathmill under Siliguri Police Station/SPC with deadly weapons with a view to commit some heinous crime. Accordingly, the information was diarized vide Khalpara TOP (under Siliguri PS) GDE No. 603, dated. 20.04.2025. Accordingly without wasting any time, I informed the matter to O/C Khalpara TOP under Siliguri PS and IC Siliguri PS over telephone and as per telephonic instruction, myself along with ASI Kalipada Roy, C/1486 Pradip Ghosh, C/390 Sujit Paul, C/244 Samim Ali, C/706 Tapan Debnath, C/1565 Santu Barman all of Khalpara TOP under Siliguri Police Station headed towards Jalpaimore Kathmill under Siliguri Police Station/ SPC to verify the veracity of the information and to work upon it. This refers Khalpara TOP-II GDE No. 604 Dated. 20/04/25 vide MCC No. 347, Dated-20/04/25. On way to the P.O I called one disinterested independent witness namely Biswajit Das (M/33 years), s/o- Nirmal Das of South Bharatnagar, near Rail Gate, ward no. 24 of SMC, PS-Siliguri, Dist-Darjeeling whom we disclosed the matter regarding our information and identity and asked him to accompany us if any search and seizure is necessary for the purpose. On the way to Jalpaimore Kathmill I also informed K-21 night mobile van officer SI Tushar Kanti Mandal to accompany us to hold raid at the said place. We reached near the spot as thrected by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement and found a group of 09/10 persons sitting there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04(four) above referred accused persons and others managed to flee away from the spot.

On interrogation the 04 (four) persons disclosed their identity as noted in the previous page and confessed that they along with 05/06 (five/six) other persons had assembled there with a view to commit dacoity after making full preparation in a shop at Jalpaimore adjacent area under Siliguri Police Station. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were recovered from their possession-

- 01 (one) steel made rod measuring approx. 85 cm in length which was found on the right hand of the accused person namely Md Azmat (M/24 years) S/O-Md. Matiullah of Kholaibaktori, Tulsinagar, PS-Matigara, Dist-Darjeeling.
- 01 (one) iron made rod measuring approx 60 cm in length which was found on the right hand of the accused person namely Md. Guddu (M/24 years) S/O-Md. Samsul of Mazumder Colony, Ward No. 04 of SMC, PS- Siliguri, Dist-Darjeeling
- 3 01 (one) iron made rod measuring approx. 90 cm in length which was found on the left hand of the accused person namely Ayush Routh (M/18 years) S/O-Bijay Routh of Tikiapara, Ward No-28 of SMC, Ambedkar Colony, PS- Siliguri, Dist-Darjeeling and
- 01 (one) iron made sword measuring approx. 70 cm in length including its iron made butt found on the right hand of the accused person namely Ajay Barman (M/20 years) S/O-Lt. Goutam Barman, Coal Depo, Ward No 07 of SMC, PS-Siliguri, Dist-Darjeeling

All the articles were seized in between 02.31 hours to 02.55 hours after issuing a proper seizure list duly signed by the witnesses and the accused persons. The whole process of seizure is videographed. Then, I arrested the above noted apprehended accused persons after issuing memo of arrest, as they had assembled with deadly weapons for committing decoity in a shop at Jalpaimore adjacent area The ground of arrest has been duly communicated with them and also informed

Under the above circumstances, I pray before you that a specific case may kindly be initiated against the 04 (four) arrested accused persons namely (i) Md. Azmat (M/24 years) S/O-Md. Matiullah of Kholaibaktori, Tulsinagar, PS-Matigara, Dist-Darjeeling, (ii) Md. Guddu (M/24 years) S/O-Md. Samsul of Mazumder Colony, Ward No. 04 of SMC, PS- Siliguri, Dist-Darjeeling (iii) Ayush Routh (M/18 years) S/O-Bijay Routh of Tikinpara, Ward No-28 of SMC, Ambedkar Colony, PS-Siliguri, Dist-Darjeeling and (iv) Ajay Barman (M/20 years) S/O-Lt. Goutam Barman, Coal Depo. Ward No 07 of SMC, PS-Siliguri, Dist-Darjeeling (Not verified) and 05/06 (five/six) other persons for assembling with deadly weapons with a view to commit dacoity.
