Subject: Fir on Physical Torture.

Respected Officer,

I Pushpa Tiruwa Chhetri, wife of Nishant Tiruwa, resident of Pattharghatta, Khopalashi Purba, Near Sharma photo studio, Sainik Puri, Khaprail, West Bengal-734009 would like to report about mental and physical torture against me by my husband namely Nishant Tiruwa S/o Dalbadhur Tiruwa. That our marriage was solemnized on 12/05/2009 through hindu customs and rituals. That out of the wedlock two children were born namely (i) Rudraansh Tiruwa (ii) Rudrika Tiruwa.

At first the marriage went off smoothly but after some time my husband's behavior started to change when he started an affair with an lady namely Dhanushree @ Nisha Barman. My husband started to pick up quarrel unnecessarily and he used to torture me everyday sometimes even physically assaulting me by putting hands on my body. My husband torture has started to increase day-by-day. One day when I confronted my husband about his affair with an lady namely Dhanushree @ Nisha Barman he started to torture me both physically and mentally. It is important to mention that during Diwali in the year 2023 I caught my husband red handed in a hotel room in pradhan nagar with the lady namely Dhanushree @ Nisha Barman when I confronted him about his affair he started abusing me in fifthly language in front of the public and started giving me life threats.

That it is important to mention my husband is a habitual drunker and who used to come home almost every day in drunken position every once in a while and used to abuse me and physically torture me. There are times when he used to beat me after being intoxicated with alcohol. Due to his excessive physically torture there were few instances when I was admitted to the hospital and some of the medical reports are still with me.

That the torture went out of hand when my husband used to abuse my mother and father in a very filthy language. That it is important to mention that I used to bear all this inhuman torture thinking one day my husband's behavior will change towards me.

That the physical and mental torture was unbearable at that point of time and in spite of the bearing such inhuman torture I couldn't please my husband ultimately I was driven out of my matrimonial home on 22 July 2024.

Even after I was driven out of my matrimonial home my husband's behavior has not changed at all he is still torturing me on regular basis and it is becoming unbearable for me to tolerate the pain and harassment on regular basis. On 06/03/2025 my husband called me and started abusing me on a very filthy language and gave me life threats that he will cause bodily injury to me.

It is important to mention that my husband is a very influential person and I have a fear that my husband will harm me at any given point of time. I would like to request you to look into this critical matter with utmost importance. I therefore request you to Investigate into this matter and take necessary steps against my husband namely Nishant Tiruwa.
