1. That I am a law abiding citizen and a respectable business man in above mention address.
2. That two persons namely 1. **RAKESH MAHATO**, S/O TarakeswarMahato, Resident of Samar Nagar, Bou Bazar, 2. **RAJU MAHATO**, S/O ChandrikaMahato, Resident of Shiv Nagar Colony was running business at Regulated Market (Fish Complex), Mallaguri.
3. That the said 1. **RAKESH MAHATO**, S/O TarakeswarMahato 2. **RAJU MAHATO**, S/O ChandrikaMahato running illegal business into the said premises of regulated fish market and was also selling an illegal article in the said premises of regulated fish market upon their muscle power with the help of other anti-social persons.

7. That it is to be mention here that everyday huge amount of business i.e., more than crores of rupees. Moreover, hundreds of persons are fully depended upon the said business each and every day.
8. That if for any reasons the market has been closed then the people who runs a business of buying and selling will have incurred a huge loss.
9. That suddenly without any realm or reason or without giving any intimidation the above named accused personson **18.04.2025** at about 6.30 am started to threat all the members of the market to close the market in respect of condolence is concern.
10. That in this regard I the secretary of the Regulated Market (Fish Complex), Mallaguri (owner of stall no.116) and the President of our association namely Partha Banerjee (owner of stall no. 112) tried to make the above named accused persons understand that if they forcefully shut down the whole market complex then huge loss for an amount of **Rs. 25,00,000/- (Rupees Twenty Five Lakhs)** will be incurred by the public in general as well as the business man of the said market complex.
11. That at these the above named accused persons become violent and started to abuse me and the President Will filthy languages and threaten me that if I and the President of out association try to go against them then they will burn us in our respected shop rooms.

That in the said hue and cry some of our other members came to the spot and try to make them understand of the present situation but the above named accused persons with the help of some anti-socials who are not at all the members of our associations as well as of any union of our market, pushed me and our President Partho Banerjee with immense power on my chest and as our President had undergone a heart surgery and pace maker has been installed become senseless and I was severely injured as I am about 65 years of age and suffering from various ailments and the above named persons forcefully pull the shutter of my shop being no 116 and the shop of our President being no 112 and when the other persons of our association tries to resist them, the above named accused persons snatched Rs. 10,000/- (Rupees Ten Thousand) only forcefully from me and started to threatened me to kill me and my other members and also threat us that they will implicate us in false cases and moreover and the above named accused persons vandalized my above mentioned stall and destroyed my business properties and personally I incurred loss of my business for an amount of **Rs. 25,000/- (Rupees Twenty Five Thousand)**.

13. That during the time of attack on **18/04/2025 at about 6.30 a.m. to 8.45 am** the above named accused persons intentionally ransacked my shop and forcefully looted away various documents from my shop with an intention to destroy the whole association for that we cannot run our office smoothly.

14. That at this I and our President sustained injuries and has been treated in Siliguri District Hospital. (the medical slip is attached herewith in the F.I.R) .

15. That the above named accused persons threatened me and the members of our association that they will destroy our

That 1. **RAKESH MAHATO**, S/O Tarakeswar Mahato 2. **RAJU MAHATO**, S/O ChandrikaMahato started to threatened with an intention to extort money that if I do not pay them Rs. 1,00,000/- (Rupees One Lakh) only then they will not allow me to run my business in my said stall and when I protested the same the above named accused persons threaten me that they will kill me if I do not pay them the said extortion money.
18. That the above named accused persons are very desperate in nature and they threatened me that if I refuse to pay them **Rs. 1,00,000/- (Rupees One Lakh) only**, then they will set my stall on fire.
19. That the above named accused persons all the time moving along with some dangerous criminals, and they are ferocious in nature and can do anything, anytime, anywhere to me so I cannot run my business for their hooliganism.
