On 14.04.25 morning at 11.00 hrs while I opened my shop and found all the articles of my shop were sceatered and so many electrical item were missing. Later I came to know that on the night of 13/14.04.25 unknown miscreants entered into my shop by breaking tin made wall and stolen the following articles my shop. I searched everywhere to find out my said stolen electrical articles but in vain. Hence, I did not lodged complaint in due time.
