## Sub:F.I.R

In producing herewith one arrested accused person named (01) Mrinal @ Kunal Roy (22) s/o Sir, Ramesh Roy of Chandan Nagar, near Health Centre, PO- Sahudangihat, PS- Bhaktinagar, dist-Jalpaiguri along with the following seized articles viz:

i] 98 (Ninety eight) bottles of "BLUREX-T" Triprolidine Hydrochloride & Codeine Phosphate cough Syrup, each bottle containing 100 Ml, having batch No. TBHX1008, Mfg. Date 03/2025, Expiry date 02/2027, value of Rs. 180/-each bottle, manufactured by Three B Healthcare Ltd. opposite Dental College, Rampur Road Paonta Sahib, dist- Sirmour (H.P.) found in a brown cartoon box, which was kept inside the dickey of the vehicle and marked as "Exhibit- A".

ii] One cream colour IPhone 16 Pro Max marked as exhibit-"B".

iii] One white colour four wheeler bearing Reg.No. WB-02-AB-6451 [VENTO] marked as exhibit-"C".

I, SI Agen Lepcha, s/o Lt. Dup Tshering Lepcha of Ashighar Out Post under Bhaktinagar Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that today on 19/04/2025 at 18:05 hours, I received credible information indicating that an individual is possessing huge quantity of illegal 'Codeine Phosphate' based drugs without any valid licence and is waiting at near Kabarstan Bholanathpara under Bhaktinagar PS in a white colour four-wheeler to sell the same to his designed customers for his illegal gain. Accordingly, the matter was diarized in General Diary vide Ashighar Out Post PS GDE No. 565/25 Dt. 19/04/2025 and subsequently, I informed the matter to the Officerin-Charge. Ashighar Out Post in written. Thereafter as per the permission of OC OP I along with ASI Dinesh Chandra Roy, ASI Tapan Roy, C/ 970 Bikash Roy all of Ashighar Out Post under Bhaktinagar PS, SPC left for Kabarstan Bholanathpara under Bhaktinagar PS along with investigation kit by Govt. vehicle to verify the veracity of the information. This refers to Ashighar OP GDE No.565, Dt.19/04/2025 and M.C.C No-476 Date- 19/04/2025.

Given the circumstances, obtaining a search warrant was impractical, as it would provide an opportunity for the suspect to conceal evidence or escape.

At the time of departure from the office, I took an envelope, white paper, sealing wax, gum, seal, digital weighing machine (Certified by the weight and Metallurgy department) and other investigation kits as they would be needed if any contraband substance was found. On the way to Kabarstan Bholanathpara I also called two independent witnesses namely (i) Abjijit Roy (19) s/o Lt. Ramesh Roy of Naresh More Papiapara, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri and (ii) Bidhan Roy s/o Keshab Roy of Papiya para PO- Goghomali, PS- Bhaktinagar, dist-Jalpaiguri. We disclosed our identities to them and requested them to accompany us and remain present as witnesses during the process of search and seizure. They also agreed to remain as witnesses.

Thereafter we proceeded towards Bholanathpara Kabarstan. On the way to Kabarstan I also asked RT van officer ASI Chandi Roy and team to come to the spot from another side so that the accused would not get the chance to escape. At around 18:45 hrs we reached near Bholanathpara Kabarstan and upon noticing our police presence, the accused became nervous and attempted to flee by starting the vehicle. However, he was stopped by our RT van police team coming from opposite direction. Thereafter we successfully apprehended him, upon which I disclosed my identity as a police officer and informed him of the purpose of our presence.

On being asked, he disclosed his identity as Mrinal @ Kunal Roy (22) s/o Ramesh Roy of Chandan Nagar, near Health Centre, PO- Sahudangihat, PS- Bhaktinagar, dist- Jalpaiguri. We informed him that we had specific information that he had in his possession a huge quantity of "narcotic substance" on his belongings and that we intended to search him and his vehicle. Initially, he denied having any "Narcotic substance" with him and at his vehicle. But I told him that we would search him in person and the vehicle. Eventually, he admitted that he had kept concealed the "Narcotic Substance" in his vehicle's dickey and was waiting there for his customer to deliver the same for his wrongful gain. He stated that he did not have any license to sell "Narcotic Substance" and that he procured the same from one person named Manab Ghosh s/o Ratan Ghosh of Ranjit More, Hatiadanga, Ashighar PS-Bhaktinagar dist-Jalpaiguri and then sell the same to his customers illegally, for his wrongful gain. It was clear that he was illegally procuring and selling the "Narcotic Substance".

I then presented him with notice options for being searched in the presence of an Executive Magistrate or a Gazetted Officer, to which he consented to a search by either. I also extended the opportunity for independent witnesses and the accused to search our police team, but they declined. I then sent ASI Dinesh Chandra Roy of Ashighar Out Post with a requisition to Shri Amit Adhikary, Inspector- In-charge- Bhaktinagar Police Station, SPC, requesting him to come to the spot to supervise the process of search and seizure.

Accordingly, at around 19:30 hours, ASI Dinesh Chandra Roy returned to the spot along with Shri Amit Adhikary, Inspector- In-charge- Bhaktinagar Police Station, SPC. He disclosed his identity as Inspector- In charge- Bhaktinagar Police Station, SPC, to the detained person as well as the independent witnesses and told them that he would be supervising the process of search and seizure. As instructed by Sri Amit Adhikary, Inspector- In-charge- Bhaktinagar Police Station, SPC and under his supervision in the presence of two independent public witnesses, search was conducted of the detained individual and his vehicle observing all formalities and then found above noted seized contraband articles inside the dickey of his vehicle and from his personal possession.

On being asked about the valid documents by Sr. Amit Adhikary, Inspector-In- charge-Bhaktinagar Police Station, SPC, the apprehended person was unable to produce any document/license in support of that "Narcotic Substance" that was in his possession. He confessed that he was carrying this business illegally. He further said that he used to procure it from Manab Ghosh s/o Ratan Ghosh of Ranjit More, Hatiadanga, Ashighar PS-Bhaktinagar and used to sell it to his customers for his wrongful gain.

Following that as instructed by Sr. Amit Adhikary, Inspector-In-charge- Bhaktinagar Police Station, SPC, I seized all above-noted articles under the proper seizure list in the presence of the above-noted independent witnesses and took the signatures of the witnesses and the accused person on the seizure list. I then labelled and sealed them as "Exhibit-A", "Exhibit-B", and "Exhibit-C", in the presence of the Inspector-In-charge- Bhaktinagar Police Station, independent witnesses and the accused. The seizure was made in between 19:35 hr to 19:59 hrs. The whole process of search and seizure was properly video-graphed.

The apprehended accused person namely Mrinal @ Kunal Roy confessed before the Inspector-In-charge- Bhaktinagar Police Station and other witnesses that he used to procure "Narcotic Substance" clandestinely from Manab Ghosh for the purpose of selling the same to his designed customers for his wrongful gain by illegal means and that he was doing this for a long time.

I then arrested the apprehended accused person namely Mrinal @ Kunal Roy (22) s/o Ramesh Roy of Chandan Nagar, near Health Centre, PO- Sahudangihat, PS- Bhaktinagar, dist- Jalpaiguri under proper Memo of Arrest for violating the terms and condition of the NDPS Act, after observing all guidelines of Apex Court. His ground of arrest was duly communicated to him.

Under the above circumstances, I pray before you that a specific case under the proper section of law may kindly be started against the following accused person named Mrinal @ Kunal Roy (22) s/o Ramesh Roy of Chandan Nagar, near Health Centre, PO- Sahudangihat, PS- Bhaktinagar, dist- Jalpaiguri and Manab Ghosh s/o Ratan Ghosh of Ranjit More, Hatiadanga, Ashighar PS-Bhaktinagar and arrange for its investigation.
