Sir / Madam

I want to inform you that , I Dildoz Ansari , S/O – Abdul Hakim , Resident of – Hathnama ,  
po: Dudhani , PS : Jarmundi , Dist : Dumka, Jharkhand , Pin 814141 .

I Dildoz Ansari, a resident of Dumka district of Jharkhand. I and my elder brother Jarjis  
Ansari (34) have been working in a private company in Choto Phapdi, Siliguri for the last 4 years.  
And we live in a rented house in Ashraf Nagar , Ward No 40, behind ISKCON temple. As usual, today  
at around 6 pm, in front of Chhota Fafri bridge near Amarpati Vidyalaya my elder brother and I  
completed all the work of the company and left for our rented house to rest. But, on the way back, a  
commercial vehicle car ( Vehicle : TATA AC ; Vehicle no : WB 71 B 9728 ) came in front of my  
brother and hit him from back . As a result, my brother fell unconscious on the road in a bloody  
state. He was taken to the hospital, and on the spot he died. Later I took him to the Siliguri  
Anandlok Hospital and the doctors declared him as dead.

As Information , My brother is the one only earner of his family. His family consists of his wife  
Razia Bibi along with 5 childrens whose names are -(1) Farhan Ansari ( Age : 13 ) ; (2) uamema khatun  
( age : 7 ) ; (3) Raiyan Ansari ( Age : 5); (4) Aisha Siddiqua ( Age : 4 Months old ) & (5) Hafsa Siddiqua  
( Age : 4 Months Old ) . Both are twins .

At present they have no one to see. So, we are helpless and beg you to please give justice to  
our family. And give appropriate punishment to the guilty. And if they are in accordance with the  
law, please make arrangements to provide a lifetime subsidy to our entire family.
