- I, **SRI ARUN KUMAR YADAV**, S/o. Late Narayan Yadav, r/o. Jaldumur Para, Sahudangihat, Dabgram(P), P.O.-Kamarvita, Dist.-Jalpaiguri, West Bengal-735135, would like to bring to your notice the following facts:
- 1. That my brother namely Sri Vijay Kumar Yadav is the registered owner of a piece of land admeasuring 2(two) kathas situated at Jaldumur Para, Sahudangihat, Dabgram(P), P.O.-Kamarvita, Dist.-Jalpaiguri, West Bengal-735135 by virtue of a Deed of Conveyance(Sale) being no.3413 for the year 2020, hereinafter more fully described in the schedule herein below and hereinafter referred as "Scheduled land".
- 2. That my brother being in urgent need of money and being the absolute owner of the scheduled land decided to sale the below scheduled land to an intended purchasers namely Sri Bunty Gowala and his wife Smt. Priyanka Gowala.
- 3. That after preparation of the necessary documents for selling the below scheduled land my brother namely Sri Vijay Kumar Yadav and my minor nephew namely Master Abhijeet Kumar Yadav, 17 years old along with the intended purchasers namely Sri Bunty Gowala and his wife Smt. Priyanka Gowala and our lawyer namely Sri Dipak Saha went before the A.D.S.R. office situated at Ashighar for execution of the Deed of Conveyance (Sale) on 17.04.2025.
- 4. That while my brother, my nephew, the intended purchasers, witnesses and his lawyer were inside the office of the A.D.S.R. situated at Ashighar doing necessary formalities for registration of the said sale deed suddenly my brother Sri Vijay Kumar Yadav saw my brother namely SRI ANJANI KUMAR YADAV and his wife SMT. MAMATA KUMARI JADAV suddenly came running towards inside the office of the A.D.S.R. and started make hue and cry and also started abusing my brother, my nephew, the intended purchasers, witnesses and his lawyer in filthy languages. Seeing the situation getting worse my brother Sri Vijay Kumar Yadav informed me over phone regarding the said quarrel and I immediately rushed towards the office of the A.D.S.R.
- 5. That as soon as I reached there I saw that my brother Sri Vijay Kumar Yadav, the intended purchasers, witnesses and his lawyer are tremendously heckled by SRI ANJANI KUMAR YADAV and his wife SMT. MAMATA KUMARI JADAV and not only that they are also abusing them in filthy languages and I immediately went there to stop such quarrel but as I tried to stop them they pushed me using their brute force and started hitting my brother Sri Vijay Kumar Yadav and my minor nephew namely Master Abhijeet Kumar Yadav, 17 years old with fists and blows.
- 6. That seeing SRI ANJANI KUMAR YADAV and his wife SMT. MAMATA KUMARI JADAV hitting my minor nephew namely Master Abhijeet Kumar Yadav, 17 years old I went in between to protect my nephew but instead they also started hitting me very brutally with fists and blows and also started kicking me. Not only that they also used some sharp cutting objects and hit me with the same in my eyes for which I suffered a brutal injury around my eye and I immediately fell down.

- 7. That seeing the same some officers of your good office intervened in between and somehow me and others present there with us were saved.
- 8. That after suffering such injury I was immediately taken to my home and as I was facing some trouble with my eyesight and other injuries, on the very next day i.e. on 18.04.2025 I was taken to the Siliguri Sadar Hospital and after a preliminary diagnosis the doctors admitted me in the hospital and I was admitted till 19.04.2025 i.e. today and discharged.

That from the acts and conducts it is crystal clear that the said SRI ANJANI KUMAR YADAV and his wife SMT. MAMATA KUMARI JADAV with their clear intention to grab the land and for some other reasons best known and for their illegal gain did such acts and not only that their desperation went to such an extent that they even took the law into their own hands and abused and physically assaulted me with a sharp cutting object with an intention to kill me and such tantamount to penal offences under proper provisions of law.

20. That as I was admitted at the Siliguri Sadar Hospital and was discharged today that is why there is little bit of delay in lodging this present complaint.

Therefore I will be highly obliged if you kindly look into the matter and do the needful and further take necessary legal action in this regard.
