beg to inform you that on dt. 16.04.2025 at about
05.30 pm, when I along with my mother namely,
Buloddevi Singh (75) W/o Sri Narayan Singh, of
South Station Para, Naxalbari, reached at Thankar More
P.S Siliguri, at that time the above noted alleged
persons came there following us and got down
from a swift desire car, and restrained us and
started beating us brutally with fist & blows
and my old aged mother namely Buloddevi Singh (75)
received severe injury on her person and later on I
treated her at Rural Hospital, Naxalbari, Distt -
Darjeeling. I shocked with this incident, so I was in
trauma and couldn't lodge the complaint at time.

So the above noted alleged persons are of very
desperate & dangerous in nature, & they have stolen
away my gold chain from my neck, and they have
threatened us for dire consequences.
