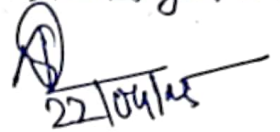

I, Rashed Hossain, Contingent driver of Mail Motor Service, Siliguri want to complain about an incident happened at NJP Kalibari near Kali Mandir. I was driving the mail van bearing registration no. WB05-8724 from Siliguri Head Post Office to NJP Railway Station for receiving the mails. On the way, some unknown persons on scooter coming from opposite side used slang languages and after some time, came back to stop the vehicle on road. They stopped the vehicle and started to beat us while we are on duty. They snatched off my mobile phone and beat me and the mail guard. The wind shield of the mail van had been broken by them.
