Sir,

In producing herewith the following seized articles as per seizure list viz :- (i) One vehicle having Registration number WB/71/0564 loaded with river bed materials and (ii) 05 (five) numbers of shovels.

I, SI Bandhan Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the driver and owner of the above mentioned seized vehicle having registration number WB/71/0564 to the effect that today On 23.04.2025 at approximately 07:30 hrs, I received a specific source input regarding illegal mining activity being carried out at the Mahananda river bed near Military Ghat. It was reported that river bed materials were being illegally excavated and loaded onto the vehicle having Registration No. WB/71/0564 for their illegal gain. Upon receipt of the information, I made a General Diary entry vide Pradhan Nagar PS GDE No. 1218 dated 23.04.2025 and informed to you. As per your kind order and direction, I proceeded with a team in a Govt. vehicle to verify the veracity of the information.

On the way the source informed that the said vehicle loaded with illegal river bed materials proceeding towards Dakshin Palash. At around 08:05 hrs near Dakshin Palash, the said vehicle was spotted. Upon noticing the police presence, the driver attempted to flee but abandoned the vehicle on ground of Dakshin palash and escaped on foot. Despite efforts, the driver could not be apprehended. Upon physical verification, the vehicle having Registration No. WB/71/0564 was found to be loaded with illegally mined river bed materials. Enquiries regarding the owner and driver yielded no leads as both were found to be absconding. Accordingly a proper seizure was carried out viz: one vehicle bearing Reg. No. WB/71/0564 loaded with illegally mined river bed materials and five numbers of shovels at the site in between 08:25 hrs to 08.40 hrs under video surveillance under section 106 BNSS.

Under the above circumstances, I pray before you that a case be registered under appropriate sections of law against the driver and owner of the vehicle bearing Reg. No. WB/71/0564 involved in illegal mining, and arrange for its investigation.
