In producing herewith the following seized articles as per seizure list viz:- (i) One vehicle having Registration number WBY/1456 loaded with river bed materials.

I, ASI Jagannath Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the driver and owner of the above mentioned seized vehicle having registration number WBY/1456 to the effect that today On 23.04.2025 at approximately 08:45 hrs during my RT Mobile van duty viz: Pradhan Nagar PS GDE No. 1219 dated 23.04.2025, MCC No. 849 dated 23.04.2025 I received a specific source input regarding illegal mining activity being carried out at the Mahananda river bed near Military Ghat. It was reported that river bed materials were being illegally excavated and loaded onto the vehicle having Registration No. WBY/1456 for their illigal gain. Upon receipt of the information, I was informed to you. As per your kind order and direction, I proceeded with a team in a Govt. vehicle to verify the veracity of the information.

On the way the source informed that the said vehicle loaded with illegal river bed materials proceeding towards Dakshin Palash. At around 10.05 hrs near Dakshin Palash, the said vehicle was spotted. Upon noticing the police presence, the driver attempted to flee but abandoned the vehicle on ground of Dakshin palash and run away. Despite efforts, the driver could not be apprehended. Upon physical verification, the vehicle having Registration No. WBY/1456 was found to be loaded with illegally mined river bed materials. Enquiries regarding the owner and driver yielded no leads as both were found to be absconding. Accordingly a proper seizure was carried out viz: one vehicle bearing Reg. No. WBY/1456 loaded with illegally mined river bed materials at the site in between 10.30 hrs to 10.45 hrs under video surveillance under section 106 BNSS.

Under the above circumstances, I respectfully request that a case be registered under appropriate sections of law against the driver and owner of the vehicle bearing Reg. No. WBY/1456 involved in illegal mining, and arrange for its investigation.
