Sir,

It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against NIKITA MUNDA(USER), W/O- LT DHANSIT MUNDA, Address- Dhaknikata, Ward No-46, P.S Pradhannagar, Dist-Darjeeling, Pin-734003 for *using a domestic meter for commercial purposes*.

Today i.e, on 23.04.2025(13:50 hrs), I came to Dhaknikata, Ward No-46, P.S Pradhannagar, Dist-Darjeeling; in my officially hired vehicle for a routine inspection. I was accompanied by (i) Bijay Lakra, DE(S&LP), Darjeeling Region, (ii) Bhoben Roy, SO(S&LP), (iii) Rabi Sankar Singh, O.E, Pradhannagar CCC & other technical staffs of Pradhannagar CCC. On inspection of the premises (after observing all formalities), I found that the meter T1410863 (Consumer Name- DHANSIT MUNDA, Domestic Category, Con Id-412215752) is being used for commercial purposes.

NIKITA MUNDA(USER) is the present user of the premises.

I disconnected the connection of NIKITA MUNDA(USER) & seized the meter T1410863, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- 1 phase energy meter T1410863, 240V, 5-30A, Make- L&T (L/R-24928)

NIKITA MUNDA(USER) was present at the premises and received the Notice, Inspection Sheet & Seizure list.

As such, NIKITA MUNDA(USER), has been found to be using a domestic meter for commercial purposes and is liable for prosecution U/S 135 1(e) of Electricity Act 2003. Hence, you are requested to treat this as FIR.
