In producing herewith seven (07) accused persons namely (i) Karan Subba (28 yrs) S/O Sir, Late Ganga Subba of Gurung Busty, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Krishna Subba (30 yrs) S/O Late Ganga subba of Gurung Busty, PS- Pradhan Nagar, Dist. Darjeeling (iii) Dipen Gurung (38 yrs) S/O Late Kalu Gurung of Sesbatti, Race Course Para, PS- Kotwali, Dist. Jalpaiguri (iv) Md Firoz (27 yrs) S/O Md Ainul of 8th mile, PS- Kalimpong, Dist.- Kalimpong (v) Ujjal Chhetri (34 yrs) S/O Uday Chhetri of Pokhrebong, PS- Sukhia Pokhri, Dist. Darjeeling (vi) Sonam Lama (36 yrs) S/O Late Arjun Lama of Dagapur, Panchanadi, PS- Pradhan Nagar, Dist. Darjeeling and (vii) Munna Mandal (30 yrs) S/O Late Shyamchan Mandal of Nandigram, near

Tinbatti, PS- NJP, Dist. Jalpaiguri under arrest and the following articles under seizure viz :- (i) 01 (one) iron made Crow bar, approx measuring 24 inches (ii) 01 (one) iron made Crow bar, approx measuring 18 inches, (iii) one iron made sharp cutting sword with wooden hendel measuring 28 inches, (iv) one hammer with wooden handle approx measuring 10 inches, v) one iron made rod measuring approx 20 inches in length (vi) one iron made plier (vii) one iron made wronch measuring approx 8 inches in length (viii) one Hacksaw with blade measuring approx 16 inches in length with it wooden handle (ix) one sharp cutting iron made weapon locally called as

Hasua measuring 22 inches in length and (x) one multi colour nylon carrying bag.

I, SI Bandhan Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted seven (07) arrested accused persons and others 04/05 unknown miscreants who involve in this crime to the effect that on 24.04.2025 at 00.15 hrs I received a specific source information that about 11/12 miscreants equipped with deadly weapons assembled at Himachal Colony under PS- Pradhan Nagar, Dist. Darjeeling and they are taking preparation for committing Dacoity at Himachal Colony and its surrounding area.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 1274 dated 24.04.2025 and as per your kind order and direction myself accompanied with SI Rajiv Subba, ASI Biplab Kr. Das, ASI Prabal Sarkar, C/1411 Ashok Roy, C/1413 Sujit Sarkar and C/1416 Dilip Barman and all of Pradhan Nagar PS, SPC left Himachal Cololy, PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night RT K-30 van officer SI Pranab Singh of Pradhan Nagar PS and request him to come to Himachal Colony More to accompany us. At around 01.35 hrs we arrived at near Himachal Colony More and after a while R.T. van officer SI JPranab Singh arrived there. I shared the information with them and briefed them properly. Then, I contacted with my source and from a considerable distance he pointed the place where we noticed a suspicious movement of group of miscreants. Then, I contact with two independent witnesses namely (i) Anikul Sk S/O Kismat Sk of Devidanga, behind petrol pumo, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Bishal Kr Jha S/O Alit Kr Jha of Shiv Nagar, Darjeeling More, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards Himachal Colony and cordoned the place from every corner with due care and cautioned and from a considerable distance we noticed that some persons were assembled in a varanda at Himachal Colony and they were whispering in a low voice, the movement of those persons were very suspicious. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted 07 (seven) accused persons while 04/05 others unknown miscreants managed to fled away from the spot, taking the advantage of darkness. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted articles (house break weapon as well sharp cutting weapons) from their joint possession which was they kept conceal inside a multi colour nylon carrying bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 04/05 of their associates assembled there and were making preparation for committing Dacoity at Siliguri Junction and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 02.15 hrs to 02.45 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed regarding ground of their arrest. The whole process of search and seizure were made under the coverage of video graphy as per norms of BNSS and brought all the 07 arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted 07 accused persons along with theirs others associeates (who managed to fled away) assembled there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Himachal colony Siliguri Junction and its surrounding area.

Under the above circumstances, I pray before you that a specific case against may kindly be started against the accused persons namely i) Karan Subba (28 yrs) S/O Late Ganga Subba of Gurung Busty, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Krishna Subba (30 yrs) S/O Late Ganga subba of Gurung Busty, PS- Pradhan Nagar, Dist. Darjeeling (iii) Dipen Gurung (38 yrs) S/O Late Kalu Gurung of Sesbatti, Race Course Para, PS- Kotwali, Dist. Jalpaiguri (iv) Md Firoz (27 yrs) S/O Md Ainul of 8th mile, PS- Kalimpong, Dist.- Kalimpong (v) Ujjal Chhetri (34 yrs) S/O Uday Chhetri of Pokhrebong, PS- Sukhia Pokhri, Dist. Darjeeling (vi) Sonam Lama (36 yrs) S/O Late Arjun Lama of Dagapur, Panchanadi, PS- Pradhan Nagar, Dist. Darjeeling and (vii) Munna Mandal (30 yrs) S/O Late Shyamchan Mandal of Nandigram, near Tinbatti, PS- NJP, Dist. Jalpaiguri and others 04/05 unknown miscreants under proper section of law and arrange for its investigation.
