I asked the owner of Shop Sri Rathi Retail to return the device by following RVP task steps. At first the owner didn't answer to my questions. Then I waited over there for some time. After that the owner told me to leave the place. I lastly just asked him that he will keep the machine or not. After listening my words the owner instantly started using dedicated me. Then I try to convince him to keep Calm and inform the company Policy that the monthly rental will be charged till he submitted the device. Immediately the owner continued his dirty slangs and started hitting me by hands. He also ordered his worker to hold me and he then continuously started hitting me and threaten me that he will broke my hands and legs. He's worker did not touch me but the owner continuously bitted me, he slapped me and punched me also try to broke my wrist. Some how I saved myself and managed to escape from there.

I beg to state that he hurt me physically
and also hurt me by giving threatening to me.
Therefore please take necessary steps against him
and punished him as per law.
