Subject: Written Complaint against 1. Bipul Saha, S/o Lt. Rebott, Resident of Thiknikata, Sushrata Nagar, Rangeela Hardware Shop, Matigara, Dist: Darjeeling & 2. Other associates of his family and hired anti social people / goons.

Respected Sir,

With due respect and humble submission I, Avijit Roy, S/o Lt. Amal Kr. Roy, residing at Kawakhali, Sushrata Nagar, BPCL Petrol Pump, P.O. & P.S. Matigara, Dist: Darjeeling - 734012, would like to inform you to the following effect that I am running a aforesaid clinic / Doctors chamber situated at Ratan Lal Brahman Sarani, Shanti Niketan Lodge, Front shop of the lodge [Marketing Office] for the past 19 years and the aforesaid person is the landlord of the said land and building.

It is pertinent that on 22.04.2025, at around 09:03 A.M. in the morning I received a call from my brother Mr. Debrata Roy, who is also running a shop in the same locality informed me that the aforesaid person Bipul Saha came to my clinic and broke the pad lock of my shop without consent and in my absence and tried to evict the medical equipments of my shop and also opened the drawer of my desk in which cash was kept of Rs. 25,000/- [Twenty Five Thousand] approx. after such information from my brother I immediately rushed to my said clinic with my wife namely Sujata Roy, and was present there exactly at around 11:30 A.M. and I found that the aforesaid person was still present in the said chamber and was trying to tarnish the medical equipments and evicting the said equipments from the said clinic to some other place and the desk was wide open in which cash was kept, and I also found that the second door adjacent to my clinic in the said lodge was wrecked by this aforesaid person.

It is pertinent to mention that when I asked for such act of the aforesaid person the aforesaid person started to have a physical vigor with me and started abusing me along with his wife, son and daughter along with some other hired goons who were carefully waiting for a moment for physical fist with me and my wife. The reason of such act of the aforesaid persons Bipul Saha was a premeditated and driven by previous enmity and ongoing legal issues.
