Matigara, Dist: Darjeeling – 734012, would like to inform you to the following effect that I am running a aforesaid clinic / Doctors chamber situated at Ratan lal Brahman Sarani, Shanti Niketan Lodge, Front shop of the lodge [Marketing Office] for the past 19 years and the aforesaid person is the landlord of the said land and building.
