Sir,

With due respect and humble submission, I beg to report before you that I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodged this written complaint against following persons to the effect that on 23.04.25 at night about 02.15 hrs while performing PS night mobile van duty myself along with SI Yuel Lepcha, ASI Khagen Barman, Const 374 Debraj Biswas had been to Firangee Restaurant cum Bar situated at Sevoke road under Bhaktinagar PS for routine visit of closing Bar in time at 02.00hrs as per order of The Superintendant of Excise, Jalpaiguri vide order no-82/E Dated 22.04.25 and found that the Bar was running in that time after violation of permission by Excise department, Govt of West Bengal, The Bar was running up to 02.15AM after violating the Govt order. I checked the CC Camera footage where I found the Bar was running up to 02.15AM after violating the Govt order. I recorded the same from mobile phone.

During enquiry it came to learn that one (1) Palash Das-37yrs s/o Jayanta Das (ph-7738205141) Vill+ PO-Mahishadal Purba Medinipur A/p Staff of Firangee Pab & Bar building Sevoke road PS Bhaktinagar Dist Jalpaiguri are involved in this crime under the leadership of Ankit Agarwal s/o Rajendra Prasad Agarwal of Ramjora bazaar, PS Birpara Dist Alipurduar (9733064231)

I therefore pray that a specific case may kindly be initiated against the accused persons viz. (1) Palash Das-37yrs s/o Jayanta Das (ph-7738205141) Vill+ PO-Mahishadal Purba Medinipur A/p Staff of Firangee Pab & Bar building Sevoke road PS Bhaktinagar Dist and (2) Ankit Agarwal s/o Rajendra Prasad Agarwal of Ramjora bazaar, PS Birpara Dist Alipurduar (9733064231) Jalpaiguri under proper sections of law.
