I, Ranadip Mazumder, S/O:-Late Kalipada Mazumder, AE & Station Manager, Powerhouse CCC, WBSEDCL empowered by The Indian Electricity Act 2003 amended on 2007 do here by writing to report a serious incident that occurred on 23.04.2025 at Chayan Para, Eastern Bypass (Near Foresta Bhawan), which I believe warrants immediate attention and investigation. The incident involved an accident by unknown vehicle with 8 Mtr PCC pole of our electrical installations, that caused significant damage to WBSEDCL's property and public safety.

As 'No Power' complaint received from different consumers of the said location, Our technical team attend the spot immediately at 12:15 PM and found that 02(two) 8 Mtr PCC pole broken with damage of other electrical installation due to accident with unknown vehicle. Power Restoration work commenced from 2:45 PM by replacing the broken Pole and other allied materials. Completion of maintenance work & restoration of Power at the said location completed at 6:45 PM (Dated: 22.04.2025).

The total financial losses caused due to this accident are approximately Rs68713.00 (Sixty Eight Thousand Seven Hundred and thirteen) only.

Given the potential risks and significant financial implications, I kindly request you that a General Diary be registered regarding this accident. Your prompt attention to this matter is crucial to ensure the safety of the community and the protection of WBSEDCL property. This is for your kind information and further needful action please as per law.
