Sir,

With due respect and humble submission, I beg to report before you that I, SI Youel Lepcha s/o Jai Tshering Lepcha of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodged this written complaint against following persons to the effect that on 24.04.25 at night about 02.10 hrs while performing PS night mobile van duty myself along with SI Srimanta Chatterjee, ASI Khagen Barman, Const 374 Debraj Biswas had been to Hiccups Restaurant cum Bar situated at Sevoke road under Bhaktinagar PS for routine visit of closing Bar in time at 02.00hrs as per order of The Superintendent of Excise, Jalpaiguri vide order no-82/E Dated 23.04.25 and found that the Bar was running in that time after violation of permission by Excise department, Govt of West Bengal, The Bar was ruining up to 02.10AM after violating the Govt order. I checked the CC Camera footage where I found the Bar was ruining up to 02.10AM after violating the Govt order. I recorded the same from mobile phone. During inquiry it came to light that Kishan Karjee (26years) S/O Suman Karjee of Salkuma Falakata, PS Falakata, Dist Alipurduar Staff of Hiccups Pab & Bar building Sevoke road PS Bhaktinagar Dist Jalpaiguri is involved in this crime under the leadership of Kishor Biswakarma S/O Shambu Biswakarma of Lalpul near Lalpul Bazar, PS Naxalbari, Dist Darjeeling.

Further I tried to control the situation but the aforesaid Kishan Karjee directly refused to follow the instruction and as well as did not co operate the police. Hence I arrested the said Kishan Karjee u/s 35 of BNSS for preventing the accused from committing any further offence and to control the situation.

I therefore pray that a specific case may kindly be initiate against the accused persons namely 1) Kishan Karjee (26years) S/O Suman Karjee of Salkuma Falakata, PS Falakata, Dist Alipurduar Staff of Hiccups Pab & Bar building Sevoke road PS Bhaktinagar Dist Jalpaiguri and 2) Kishor Biswakarma S/O Shambu Biswakarma of Lalpul near Lalpul Bazar, PS Naxalbari, Dist Dajeeling under proper sections of law.
