On 14/06/2011 my land was recorded in my name in L.R. Khatian 84 for 28 decimal which I had purchased of which copy is enclosed.

On ~~14/06/2011~~ 08/01/2025 at around 11am when I applied for digital L.R. Khatian no 84 from B.L.R. Shiv mandir, I was shocked to find the following facts that from my L.R. Khatian no 84 sold new L.R. Khatian 330, 335, 358, 359 & 373. was selected in my L.R. Khatian 84, when I had not sold a single bit of my land to any one.

All the five deed holders names are (1) ~~Sri~~ Sradha Gurung D/o Nirmal Gurung (2) Sri Sanjay Kumar Singh S/o Debenat Singh (3) Smt. Durga Kumari Chettri w/o Ram Kumar Chettri (4) Sri Abinash Rai S/o Mani Kumar Rai (5) Sri Sobit Muchia S/o War Badhur Muchia. All the above five deeds was not sold by me by my imposter a person cheater who pretended to be me as miss.
